FOR PAST SEVERAL DAYS ITALIAN PRESS HAS BEEN FILLED WITH STORIES PROTESTING IMMINENT ARRIVAL HERE OF ARGENTINE PRESIDENT VIDELA TO HEAD HIS COUNTRY'S DELEGATION TO PAPAL INAUGURAL, ANGRY, BITTER ARTICLES OBJECT TO "DICTATOR" VIDELA'S MERE PRESENCE IN ITALY WHICH SOME PAPERS CHARACTERIZE AS "INSULT TO ALL CATHULICS." POSSIBILITY OR ORGANIZED POLITICAL PROTESTS CANNOT BE DISCOUNTED.
