SUBJECT: TIMERMAN HOUSE ARREST: RULES, SECURITY ARRANGEMENTS

1. TIMERMAN WAS TRANSFERRED TO HIS HOME
(APRIL 17) IN A LARGE FEDERAL POLICE MOTORCADE. THE
MOTORCADE CONTAINED FIVE PATROL CARS AND WAS FOLLOWED
BY AN ARMED PERSONNEL CARRIER. THE ENTIRE BLOCK IN
FRONT OF TIMERMAN'S APARTMENT WAS CORDONED OFF AND ALL
TRAFFIC FOR A TIME STOPPED.

2. FEDERAL POLICE HAVE INFORMED THE LOCAL PRESS THAT
A TWENTYFOUR GUARD SERVICE WILL BE MAINTAINED AT
TIMERMAN'S BUENOS AIRES APARTMENT. IN ALL 52 POLICE
GUARDS WILL BE ASIGNED TO THE TIMERMAN DETAIL
(FOUR SHIFTS OF 13 MEN). 3 GUARDS WILL BE STATIONED
OUTSIDE TIMERMAN'S BUILDING AND 10 GUARDS WILL BE
STATIONED IN THE BUILDING--IN THE LOBBY, ON HIS
APARTMENT'S FLOOR AND EVEN TWO IN THE TIMERMAN APARTMENT.

3. IN ADDITION TO CONTROLLING ADMISSION TO THE TIMERMAN APART-
MENT, THE GUARDS WHO WILL BE RESPONSIBLE FOR CONTROLLING ALL MAIL AND
PHONE CALLS RECEIVED IN THE HOME AND TIMERMAN WILL HAVE PETTY
RESTRICTIONS LIKE AN ALCOHOLIC BEVERAGES BAN. ONLY HIS
