3. YOU SHOULD INFORM GOA OF OUR DECISION TO ABSTAIN ON THESE LOANS, DRAWING ON THE FOLLOWING TALKING POINTS:

- WE WELCOME REPORTS OF THE CESSATION OF DISAPPEARANCES AND HAVE APPRECIATED THE GOVERNMENT'S RESPONSIVENESS TO OUR REQUEST FOR INFORMATION ON THE CASES THAT HAVE ARISEN IN RECENT WEEKS.

- WE ARE GRATIFIED AT THE ASSURANCES OF THE GOVERNMENT THAT DISAPPEARANCES WILL NOT RECUR AND HOPE THAT WE MAY CONTINUE TO RECEIVE FULL COOPERATION IN ESTABLISHING THE

FACTS IN WHATEVER FUTURE REPORTS OF DISAPPEARANCES MAY COME TO OUR ATTENTION.

- WE CONTINUE TO LOOK FORWARD TO THE VISIT OF THE INTER-AMERICAN HUMAN RIGHTS COMMISSION BEGINNING ON MAY 29. WE HOPE IT WILL LEAD TO FURTHER IMPROVEMENTS.

- WE HOPE TO SEE CONTINUING IMPROVEMENTS IN THE HUMAN RIGHTS SITUATION IN OTHER AREAS OF GRAVE CONCERN.

- WE ESPECIALLY HOPE TO SEE
