Dear Mr. Harkin:

I refer to your letter of June 15 concerning the detention in Argentina of Irene Leonor Martinez under the National Executive Power (PEN).

Our Embassy in Buenos Aires has informed us that Irene Leonor Martinez was granted contolled liberty effective June 19, 1979. Under controlled liberty a person remains under the authority of the PEN but is allowed restricted travel. Miss Martinez is restricted to the city of Villa Cabrera, where her mother resides.
