DEPARTMENT IS DEEPLY DISTURBED BY REPORT (REF A, PARA 5) THAT QTE THERE IS INFORMED SPECULATION THAT SOME OF THE REMAINING CLANDESTINE PRISONERS ARE BEING MURDERED UNQTE, APPARENTLY IN CONNECTION WITH PREPARATIONS FOR THE IAHRG VISIT IN SEPTEMBER. WE WOULD APPRECIATE YOUR URGENTLY MAKING WHATEVER FURTHER INQUIRIES INTO THIS MATTER MAY BE POSSIBLE AND FURNISHING IN-DEPTH ASSESSMENT OF AUTHENTICITY OF THESE REPORTS.

DEPT ALSO REQUESTS YOUR RECOMMENDATIONS AS TO WHAT ADDITIONAL STEPS US MIGHT TAKE, PERHAPS IN CONCERT WITH OTHER CONCERNED GOVERNMENTS, (E.G., THE EC-9 AMBASSADORS) TO INFLUENCE GOA TO HALT KILLINGS. FYI: IN RECENT CALL ON HA ASSISTANT SECRETARY DERIAN, SWEDISH CHARGE SAID SWEDISH GOVERNMENT HAS RECEIVED REPORTS THAT GOA IS KILLING CLANDESTINE PRISONERS AND OFFERED TO JOIN WITH USG IN JOINT OR PARALLEL APPROACHES TO GOA TO PRESS FOR CESSATION OF KILLINGS. END FYI.

3. ALSO, PURSUANT TO EMBASSY SUGGESTION IN PARA 6 OF REF B THAT QTE THE BEST COURSE FOR DEALING WITH THE POSSIBILITY OF CLANDESTINE PRISONS IS TO CONTINUE TO SUPPORT THE IAHRG VISIT AND TO COLLECT ANY INFORMATION WHICH MIGHT ASSIST IT IN DEALING WITH THIS QUESTION UNQTE, WE BELIEVE IT WOULD BE TIMELY TO FOLLOW THROUGH ON YOUR RECOMMENDATION BY REVIEWING AVAILABLE INFORMATION WITH A VIEW TO FURNISHING APPROPRIATELY SANITIZED DATA TO COMMISSION ON A CONFIDENTIAL BASIS. DEPARTMENT THEREFORE REQUESTS YOU REVIEW INFORMATION AVAILABLE IN EMBASSY FILES FROM ALL SOURCES ON CLANDESTINE OR OTHER UNACKNOWLEDGED FACILITIES AND FORWARD A LIST AND DESCRIPTION OF ALL CENTERS YOU BELIEVE ARE PROBABLY STILL IN OPERATION.
