2. BELOW IS A PRELIMINARY OUTLINE OF A GENERAL POLICY REVIEW ON ARGENTINA THAT ARA CONTEMPLATES AS A BASIS FOR POLICY ORIENTATION IN THE '80'S. FOR THIS STUDY, WE INTEND TO SEEK INPUT BOTH FROM OFFICIAL SPECIALISTS OF RELEVANT WASHINGTON AGENCIES AND THE FIELD BUT ALSO, AS NEEDED, FROM QUALIFIED ACADEMIC OR OTHER OUTSIDE SOURCES. 3. WOULD APPRECIATE EMBASSY COMMENTS ON THIS OUTLINE AND YOUR INITIAL THOUGHTS, IN BRIEF FORM, ON THE SUBSTANCE

OF TOPICS THAT YOU FEEL YOU ARE NOW IN A POSITION TO ADDRESS WITH SOME ASSURANCE. AT THIS STAGE WE ARE NOT REQUESTING NEW RESEARCH OR ANALYSIS BUT RATHER THE GENERAL FRUITS OF YOUR EXPERIENCE AND OBSERVATION. YOUR INITIAL COMMENTS WILL BE USED AS A BASIS-FOR REVISION OF THE OUTLINE, FOR POSSIBLE REQUESTS FOR MORE SPECIFIC CONTRIBUTIONS, AND FOR A DRAFT PAPER ON WHICH YOU WILL BE ASKED TO COMMENT FURTHER. THUS WE HOPE WE CAN HAVE YOUR PRELIMINARY COMMENTS HERE WITHIN TWO WEEKS.
