SUBJECT: SOVIET GRAINS EMBARGO: CHRISTOPHER MEETING WITH ARGENTINE ECONOMICS MINISTER

- 1. ARGENTINE ECONOMICS MINISTER MARTINEZ DE HOZ CALLED ON THE ACTING SECRETARY MAY 6. ALSO ATTENDING, IN ADDITION TO STATE OFFICERS, WAS AGRICULTURE UNDER SECRETARY HATHAWAY. ASIDE FROM A BRIEF EXCHANGE AT THE END ABOUT OLYMPIC BOYCOTT, CONVERSATION CENTERED ENTIRELY ON SOVIET GRAINS EMBARGO, A SUBJECT ALSO RAISED WITH MARTINEZ DE HOZ IN SEVERAL OTHER CONVERSATIONS WITH ADMINISTRATION LEADERS.
- 2. THE ACTING SECRETARY EMPHASIZED OUR SERIOUS VIEW OF THE EMBARGO AND DESCRIBED ITS EFFECTS IN LIMITING GRAIN AVAILABILITY TO THE SOVIET UNION. HE STRESSED OUR DETERCONFIDENTIAL

UNDER SECRETARY HATHAWAY STRESSED CLOSE COOPERATION BETWEEN U.S. AND ARGENTINA, AS WELL AS AMONG ALL MAJOR GRAIN EXPORTERS, DURING LENGTHY WHEAT NEGOTIATIONS IN GENEVA AND URGED CONTINUATION OF THAT COOPERATION ON THIS DIFFICULT ISSUE. HE ALSO NOTED INFLUENCE ON

ARGENTINA, WORLD'S OTHER MAJOR CORN EXPORTER, OF U.S. CORN PROGRAMS.

- 3. MARTINEZ DE HOZ MADE LENGTHY, NONSPECIFIC RESPONSE.
 MAIN THEMES WERE: (A) LONG-TERM NATURE OF ARGENTINA'S
 GROWING TRADE RELATIONSHIP WITH SOVIET UNION, DATING BACK
 TO EARLY 1970'S, WHICH CENTERED ON GRAINS. IN THIS
 CONNECTION HE REPORTED THAT BILATERAL GRAINS AGREEMENT
 HAD BEEN UNDER CONSIDERATION FOR SO; E TIME AND WOULD
 PROBABLY BE CONCLUDED IN COMING MONTHS. (B) ARGENTINA'S
 CONCERN THAT ALLIED RESPONSE TO SOVIET AGGRESSION IS
 EXCESSIVELY FOCUSSED ON GRAINS, WHICH PLACES ARGENTINA
 AT DISADVANTAGE BECAUSE OF ITS LARGE AGRICULTURAL SECTOR.
 (C) ARGENTINA BELONGS TO THE WEST AND SHARES OUR
 CONCERNS OVER SOVIET EXPANSION.
- 4. THE ACTING SECRETARY EMPHASIZED THE BROAD SCOPE OF ALLIED RESPONSE TO THE SOVIET INVASION OF AFGHANISTAN, WHICH GOES FAR BEYOND THE GRAINS EMBARGO. HE STRESSED OUR HOPE THAT ARGENTINA WOULD RESTRAIN ITS EXPORTS WITHIN A GLOBAL SYSTEM, FOR EXAMPLE AGREEING TO A REDUCTION FROM A NORMAL LEVEL OF 2.5-3 MMT.
