ANTI-CASTRO ORGANIZATION, ARE PLANNING BOMBINGS AGAINST
VENEZUELAN AIRCRAFT AND VENEZUELAN DIPLOMATIC ESTABLISHMENTS
WITHIN THE UNITED STATES. THE ALLEGED REASONING BEHIND THE
BOMBINGS IS TO BRING PRESSURE TO BEAR UPON PRESIDENT CARLOS
PEREZ OF VENEZUELA, SO THAT HE WILL HONOR A PREVIOUS
COMMITMENT FOR PROTECTION TO ORLANDO BOSCH, A CORU LEADER
CURRENTLY IMPRISONED IN VENEZUELA FOR THE SABOTAGE OF A CUBANA
AIRLINER NEAR BARBADOS IN OCTOBER, 1976. IT WAS FURTHER
LEARNED THAT CORU WAS RESPONSIBLE FOR THE RECENT ATTEMPTED
BOMBING OF A VENEZUELAN AIRCRAFT AT MIAMI, FLORIDA, FOR WHICH
RESPONSIBILITY WAS PUBLICLY CLAIMED BY THE "PEDRO LUIS
BOITEL COMMANDOS." (S)
