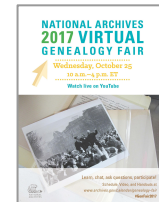

Beyond the War Relocation Authority

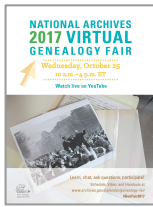
Records Relating to Japanese and Japanese Americans During World War II

Many genealogists and scholars researching individuals removed from the West Coast under Executive Order 9066 are familiar with the records of the War Relocation Authority (WRA), the Federal agency charged with relocating and housing those individuals. Outside of these often researched materials are records created by a number of other agencies, including the Immigration and Naturalization Service (INS), the U.S. military and the Federal courts – where many Japanese and Japanese Americans confronted the Federal Government over issues extending from the relocation.

"My dear Husband, Ayako and Takashi...I want to return home before Ayako gives birth to her child. Please let me know if it is a boy or a girl...After her child is born, please take good care of her, you must be very careful she must eat the best food. I would like to see the baby soon...I hope you all take good care of yourselves."

My husband and Ayako:

My dear husband, Ayako and Takashi. I am very glad to know that you are all in good health. On April 30th I received your letter enclosing the \$10 in cash, and also a letter from Washington, for which I thank you very much.

I can't understand why I can't return home, when Washington paroled me a long time ago. One week more and it will be four months since I came here. Practically all have returned to their homes except two of us - a German woman and myself. When will I be permitted to return. I have been awaiting daily word that I may go home, but not yet. How come?


I have been awaiting word daily as I want to return home before Ayako gives birth to her child. Please let me know whether it is a boy or a girl. I would like to leave for home about the time you receive this letter. I am spending my days being very lonesome. I heard that the Immigration Office does not keep people over four months. If that is true, then about the time you receive this letter I should be leaving for home - I hope so. I wanted to return home before Ayako's child is born. I am worrying about her every day, and praying that she delivers her child safely.

After her child is born, please take good care of her, you must be very careful - she must eat the best of food. I would like to see the baby soon. If I don't come home about the time you receive this letter, please ask Washington again, and also the Los Angeles Immigration Office, when I can return home. I was told that it would be within a week, or a month, but it has already elapsed more time than that - two months now, and still I cannot return home.

I hope you all take good care of yourselves.

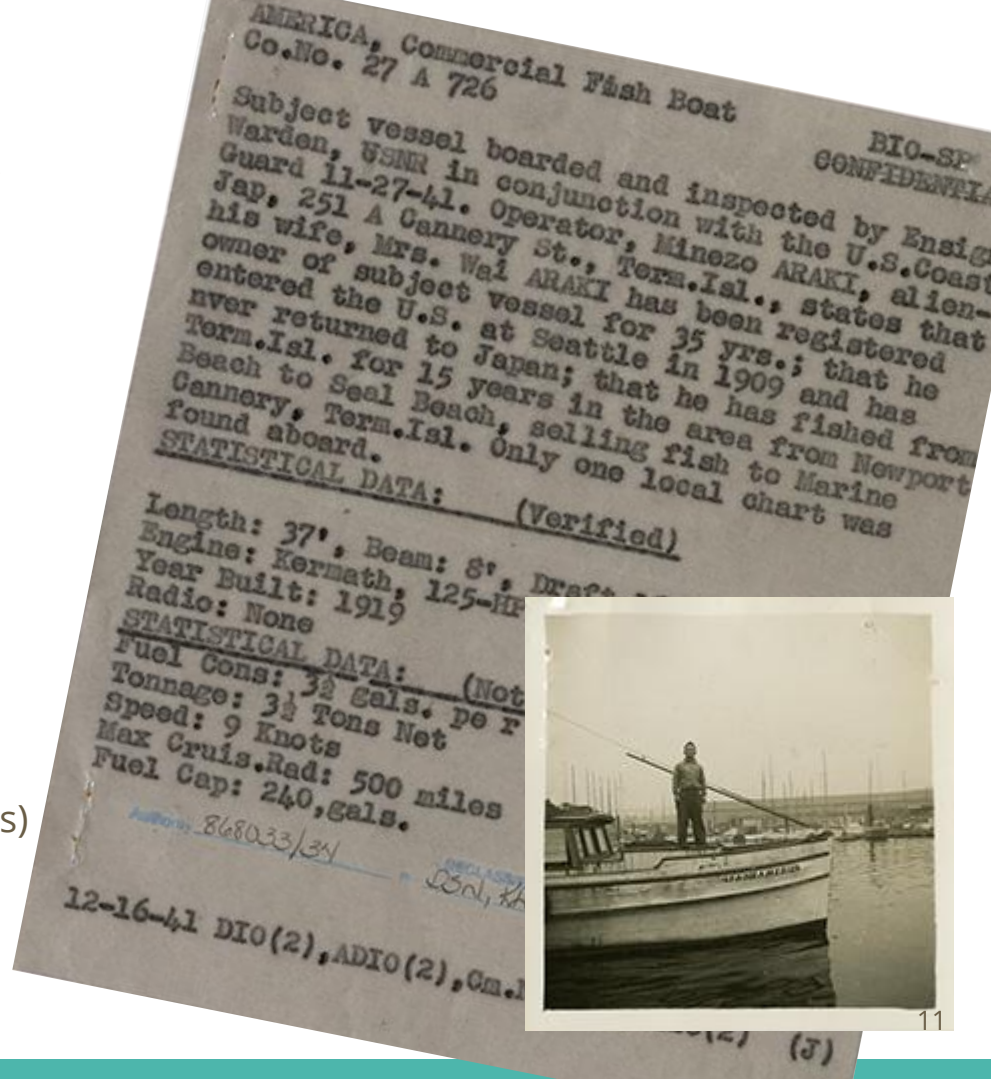

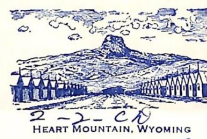

The residence in which they lived at the time of evacuation had been purchased, was modern, with adequate furnishings. Family income has been fair, has steadily increased, but, since the family has also increased steadily, it has not been possible to accumulate more than minimal savings beyond the purchase of a home. At the time of evacuation, the family's income was between two and three thousand dollars a year. The parents live largely to themselves, have seldom been interested in anything except making a living and educating their children. They are members of the Buddhist church, but are not very religious, usual recreational outlets consist of trips to the beaches and work around their home. The children have taken part in school extra-curricular diversions to a limited extent, but these usually have been limited to athletic programs. Family relationships are close, discipline is administered by the father, who, until the older children came of age, was the dominant personality in the home. Because of the parents' illiteracy in English, much of the financial part of the family affairs have been delegated to them, especially the two older ones.

B. PERSONAL DATA:

EARLY LIFE: This man was born November 16, 1920 in Gilroy, California. He began school at age 7, attended a number of different schools both in grade and high school, because his parents moved about from time to time. He took a commercial course in high school, was an average student, took part in baseball, basketball and track, but no other school organizations. It was necessary that he work evenings, week-ends and summer vacations on the farms. His attendance was regular until the last two years of high school,
