Her research focused on black education in early twentieth century Cincinnati. She also has a MLS and MA in U.S. history from the University of Maryland and a MA in African American history from North Carolina Central University. Dr. Ligon did her undergraduate work at the University of Cincinnati.

Dr. Ligon is a member of the Mid-Atlantic Regional Archives Conference (MARAC), the Association of Black Women Historians (ABWH), and the National Black Graduate Student Association (NBGSA), where she served as the national president.

Dr. Ligon is also the project lead for updating the Black History Guide for the National Archives and is an editor for the Rediscovering Black History blog.
