**November is Native American Heritage Month**

The National Archives at Chicago's holdings for Record Group 75, Records of the Bureau of Indian Affairs, include several hundred cubic feet of records that document the day-to-day way of life of numerous Native American (Indian) tribes who resided on reservations in the Great Lakes Region. While textual records make up the vast majority of our RG 75 holdings, a limited number of photographs are present. You can find a complete list of the RG 75 records series on our home page at <http://www.archives.gov/chicago/finding-aids/>.

Besides the Records of the Bureau of Indian Affairs, several other record groups at Chicago document Native Americans. For instance, Federal court records (Record Group 21) document Native American rights and treaties. Record Group 95, Records of the Forest Service, includes images of Native Americans. Record Group 79, Records of the National Park Service, includes materials on the administration and site interpretation of ancient Native American sites in the Great Lakes region such as the Hopewell Culture National Historic Park in Ohio.

Recently, archivists and education specialists from around NARA devoted their considerable expertise and revised the National Archives homepage related to American Indians. In September 1918 Private Frank Mackey, a Pottawatomie tribal member, who as a child attended the Mount Pleasant Indian School and Agency in Mount Pleasant, Michigan, and later became an Indian Assistant at the school, was reported killed in action in France. Mackey, who had been severely wounded in combat while serving with the 32<sup>nd</sup> Infantry Division, wrote administrators at Mount Pleasant to allay any fears that he had been killed.

Dear Friend:

Will write a few lines to let you know that I am still among the living. But I have been in the hospital for the last couple of months. Am getting along fine and hope to be out soon.

I have been in the hospital ever since August 3. Certainly had it soft all this time. If the bullets did n't hurt so much I'd get wounded all the time. But I was hit once and that's enough for this Injun. I almost saw the Happy Hunting Ground.

But we certainly had the Boches a-going at the time I got wounded. Tiger Bill and I were hit at the same time. I guess you know Tiger Bill - Willie Tyosh.

I suppose you remember Sam Mitchell and Mitchell Moby? They were here a few days ago and they said they were in this hospital for quite a while. I think they were sent back to their Companies.

The weather is getting pretty cold over here, and I imagine it's going to be a pretty cold winter. The Frenchmen don't seem to mind the weather very much. They work rain or shine, and every day.

I received a letter from Mr. Brazie a few days ago, and he says he is getting along pretty well with his new job in the ship-yards. He told me to tell all the Injun boys to kill all the Boches they could, and he said he prays and hopes that all of us will return safe and sound.

Well, I suppose the engineers are busy repairing pipes and boilers at the heating plant?

Well, my friend, the news is scarce around the hospital, and I hope to hear from you again.

My present address is: Private Frank Mackey, Base Hospital No. 28, A.P.O. 753, France.


Dear Frank:

After believing that you were dead for the past few months we were all very much surprised today when your letter written on October 6 was received here by Miss Fish. We are certainly all feeling very much relieved and happy to know that you were not killed and that you are recovering from your wounds and hope you will be out of the hospital and that this war will be over in a short time.

I wish you would write me and give me all the information you can regarding the boys who went over. I need this information for the files of this office and to send to the Indian Office at Washington. We heard sometime ago that Owasso Gesick was missing in action. Do you know anything about him or have you heard that he was taken prisoner? I suppose now, since everyone attended the services at the Methodist Church and listened to a funeral preached by the pastor there upon your death, we will have to hold a celebration rejoicing that we prematured in burying you.

Everything at the school is going along about as usual although we have a great many new pupils since you left here. About twenty came here from Carlisle when that school was closed and also a number of their employees. Both employees and pupils have changed considerably since you left. Nevertheless, all the old employees and pupils would be glad to see you back when you return to the Good Old U.S.A.

## Naturalization Petitions from the U.S. District Court for the Chicago Division of the Northern District of Illinois Now Online!

Through a partnership with FamilySearch, a nonprofit family history organization, all of the Petitions for Naturalization from the U.S. District Court in Chicago have been digitized. The petitions cover the years 1906 through 1991 and are freely available at all National Archives facilities, many public libraries, as well as <http://familysearch.org/collection/2212212>. Currently, however, the collection cannot be searched by name – you will need to know the petition number. Don't have the number? No worries. There are two indexes also available on the FamilySearch website: one covering petitions filed through 1950 (<http://familysearch.org/collection/1838804>) and one covering the years 1926-1979 (<http://familysearch.org/collection/2040533>).

## **Saturday Hours End at NARA Field Facilities**

Beginning November 1, 2015, the research rooms at the National Archives at Atlanta, Boston, Chicago, Denver, Fort Worth, Kansas City, New York, Philadelphia, Riverside, San Bruno and Seattle will cease intermittent Saturday hours in the research rooms. All will continue to be open to the public Monday-Friday. The decision to cancel intermittent Saturday openings was made at the agency level following a close examination of usage trends. The result will be that all National Archives field locations are open on the same days. This will increase the consistency and efficiency of our public services. No change is being made to research room schedules at the National Archives Building in Washington, DC or at the National Archives at College Park.

## **Bankruptcy Case Files No Longer held at Chicago**

The first week of September saw the last shipment of accessioned bankruptcy case files leave our facility. All accessioned bankruptcy case files held by the National Archives and Records Administration are now centralized at the National Archives at Kansas City. The National Archives at Chicago still has the indexes, dockets, journals and other records that can provide researchers with an overview of individual and company

bankruptcies that took place in Illinois, Indiana, Michigan, Minnesota, Ohio, and Wisconsin. The Federal Records Center in Chicago will also continue to hold more recent bankruptcy case files that are still owned by the U.S. Courts in our region. Bankruptcy case files can no longer be shipped back to the National Archives at Chicago.
