1, AS OF 0100 HOURS LOCAL, 12 NOVEMBER 1963, 'ALI SALIH AL-SA'DI, MUHSIN SHAYKH-RADHI, HANI FUKAYKI, HAMDI 'ABD AL-MAJID AND ABU TALIB 'ABD AL-MUTALIB WERE ALL UNDER ARREST BY IRAQI SECURITY OFFICIALS, AND A FAKE TRIAL BEING HELD AT BAGHDAD AIRPORT. IRAQI SECURITY OFFICIALS WERE AWAITING THE ARRIVAL AT THE AIRPORT OF THE SPANISH AMBASSADOR IN BAGHDAD, SO THAT THE LATTER COULD STAMP SPANISH ENTRY VISAS INTO THE PASSPORTS OF THE ABOVE-MENTIONED. IMMEDIATELY AFTER THE VISAS ARE STAMPED INTO THE PASSPORTS OF THE ARRESTEES, IRAQI SECURITY OFFICIALS PLAN TO PUT THE ARRESTEES ON AN IRAQI AIRLINES AIRCRAFT, AND EXILE THEM TO
