1. (U) This report is submitted in accordance with reference (a).

2. (E) Objectives. The operation was intended to provide up-to-date hydrographic information on a landing site at Blue Beach, using clandestine reconnaissance procedures, by an SDV team. Also, a method for anchoring the SDV 50X5 [redacted] was to be evaluated.

3. (U) Discussion. Objectives were accomplished in accordance with reference (b) and the information used to construct a hydrographic chart. The SDV anchoring techniques proved successful and are discussed in enclosure (4).

4. (E) Problems, comments, conclusions, recommendations of interest to higher authority. Enclosure (4) describes both the reconnaissance techniques used and the anchoring method evaluated which should be of interest to future SDV operational planners.
