## CERTIFICATE OF ASCERTAINMENT OF APPOINTMENT FOR ELECTORS OF PRESIDENT AND VICE PRESIDENT OF THE UNITED STATES

**TO: ARCHIVIST OF THE UNITED STATES**


**WHEREAS**, 3 U.S.C. 6 requires that the following credentials of electors for the State of Alaska for President and Vice President of the United States be transmitted to your office; and

**WHEREAS**, Alaska Statute 15.30.010 provides that electors for President and Vice President of the United States are selected by election at the General Election in presidential years; and

**WHEREAS**, under Alaska Statute 15.30.050 a vote marked for the candidate for President and Vice President is deemed and counted as a vote for the presidential electors of the party; and

**WHEREAS**, pursuant to Alaska Statute 15.30.020, following are three candidates for electors for each party with a candidate for President and Vice President on the 2012 General Election ballot

**WHEREAS**, pursuant to the Act of June 25, 1948, 62 Stat. 672, as amended, 3 U.S.C. 6, Sean Parnell, Governor, and Mead Treadwell, Lieutenant Governor, do solemnly certify that in the General Election of November 6, 2012, the votes cast for President and Vice President, respectively, were 164,676 votes cast for Mitt Romney and Paul Ryan of the Alaska Republican Party; 122,640 votes cast for Barack Obama and Joe Biden of the Alaska Democratic Party; 7,392 votes cast for Gary Johnson and James P. Gray of the Alaska Libertarian Party; 2,917 votes cast for Jill Stein and Cheri Honkala of the Green Party.




