for President and Vice President of

Pursuant to the Laws of the United States of America and the District of Columbia, I, Vincent C. Gray, Mayor of the District of Columbia, do hereby certify that an election was held in the District of Columbia on the sixth day of November, two thousand twelve, for the purpose of choosing by ballot three Electors for the election of a President and Vice President of the United States, for the terms prescribed by the Constitution of the United States to begin at noon on the twentieth day of January, in the year two thousand thirteen.

The District of Columbia Board of Elections has certified the results of said election in accordance with Section 1 of the District of Columbia Election Code of 1955, approved August 12, 1955 (69 Stat. 699; D.C. Official Code Section 1-1001.01), as amended by Public Law 87-389, approved by Congress on October 4, 1961. The Board of Elections has ascertained that the Electors for the candidates receiving the highest number of votes meet all legal requirements to serve as Electors for the District of Columbia, and have sworn an oath to faithfully vote their respective ballots.

On the basis of said certification, I do hereby declare and certify that these Electors,

*Yvette M. Alexander, Donald R. Dinan, and William P. Lightfoot*

have been duly chosen and appointed Electors of the District of Columbia for the election of a President and Vice President of the United States of America.

I do further certify that, on the basis of the count of the ballots cast in said election conducted by the District of Columbia Board of Elections, the number of votes received by all candidates is as follows:

Electors of Democratic Party candidates for President and Vice President, Barack Obama and Joseph Biden, respectively, received 267,070 votes. The Democratic Party's Electors are Yvette M. Alexander, Donald R. Dinan, and William P. Lightfoot.

Electors of Republican Party candidates for President and Vice President, Mitt Romney and Paul Ryan, respectively, received 21,381 votes. The Republican Party's Electors are Jose E. Cunningham, Robert Kabel, and Margaret Melady.

Electors of DC Statehood Green Party candidates for President and Vice President, Jill Stein and Cheri Honkala, respectively, received 2,458 votes. The DC Statehood Green Party's Electors are David Bosserman, Jenefer Ellingston, and Ann Wilcox.

Electors of Libertarian candidates for President and Vice President, Gary Johnson and James P. Gray, respectively, received 2,083 votes. The Libertarian Electors are Christopher Robert Barron, John Vought LaBeaume, and Bruce Majors.

Seven hundred seventy-two ballots contained write-in votes for the President and Vice President, and are therefore not represented in the Electoral College.

Therefore, the Board of Elections hereby declares the following individuals to be winners of the office of Elector of President and Vice President of the United States and certifies the following election results:

- 1) is a qualified elector registered in the District of Columbia;
- 2) has certified to us that he or she has resided in the District of Columbia continuously for a period of three (3) years immediately preceding November 6, 2012;
- 3) has been officially designated by the D.C. Democratic Committee as the Democratic Party's nominees for the office of Elector pledged to the Democratic Party's Presidential nominees; and
- 4) has taken an oath that he or she will vote in the Electoral College for the Presidential and Vice Presidential nominees of the Democratic Party.


