## CERTIFICATE OF ASCERTAINMENT OF APPOINTMENT FOR ELECTORS OF PRESIDENT AND VICE PRESIDENT OF THE UNITED STATES

**TO: ARCHIVIST OF THE UNITED STATES**

**WHEREAS**, 3 U.S.C. 6 requires that the following credentials of electors for the State of Alaska for President and Vice President of the United States be transmitted to your office; and

**WHEREAS**, Alaska Statute 15.30.010 provides that electors for President and Vice President of the United States are selected by election at the General Election in presidential years; and

**WHEREAS**, under Alaska Statute 15.30.050 a vote marked for the candidate for President and Vice President is deemed and counted as a vote for the presidential electors of the party; and

**WHEREAS**, pursuant to Alaska Statute 15.30.020, following are three candidates for electors for each party with a candidate for President and Vice President on the 2016 General Election ballot.

**WHEREAS**, pursuant to the Act of June 25, 1948, 62 Stat. 672, as amended, 3 U.S.C. 6, Bill Walker, Governor, and Byron Mallott, Lieutenant Governor, do solemnly certify that in the General Election of November 8, 2016, the votes cast for President and Vice President, respectively, were 163,387 votes cast for Donald J Trump and Michael R Pence of the Republican Party; 116,454 votes cast for Hillary Clinton and Tim Kaine of the Democratic Party; 18,725 votes cast for Gary Johnson and Bill Weld of the Libertarian Party; 5,735

votes cast for Jill Stein and Ajamu Baraka of the Green Party; 3,866 votes cast for Darrell L. Castle and Scott N. Bradley of the Constitution Party; 1,240 votes cast for Rogue De La Fuente and Michael Steinberg as a non-affiliated candidate.
