**W**E, the undersigned, Electors of President and Vice President of the United States of America, for the respective terms beginning on the twentieth day of January, in the year of our Lord two thousand and seventeen; being electors duly and legally appointed and qualified by and for the State of Connecticut, as appears by the annexed lists of electors, made, certified and delivered to us by the Executive of the State, having met and convened at the Capitol, in Hartford, in said State, in pursuance of the Constitution and laws of the United States, and in the manner provided by the laws of the State of Connecticut, on the first Monday after the second Wednesday in December, being the nineteenth day of December, in the year of our Lord two thousand and sixteen,

**Do Hereby Certify,** That being so assembled and duly organized, we proceeded to vote by ballot, and balloted first for such President and then for such Vice President, by district ballots.

**And We Further Certify,** That the following are two distinct lists; one, of the votes for President, the other, of the votes for Vice President, so cast as afforesaid:






