WHEREAS, Bradley A. White, a duly nominated and elected Presidential Elector for the State of Mississippi has failed to attend and give his vote at the regularly-scheduled meeting of the Electoral College;


WHEREAS, Article II, Section 1, Clause 2 of the United States Constitution grants authority for each State to appoint electors, "in such Manner as the Legislature thereof may direct;"


WHEREAS, Section 4 of Title 3 of the United States Code provides that each State may, by law, provide for the filling of any vacancies which may occur in its college of electors when such college meets to give its electoral vote; and

WHEREAS, Section 23-15-789, Miss. Code Ann. (1972) directs the electors present at the regularly-scheduled meeting of the Electoral College to appoint "some person or persons to fill the vacancy or vacancies."




