WHEREAS, an election was held in the State of Delaware, on Tuesday, the third day of November, in the year of our Lord two thousand twenty, that being the Tuesday next after the first Monday in said month, in accordance with the provisions of the Constitution and Laws of the State of Delaware, in that behalf, for the purpose of choosing by ballot three Electors for the election of a

PRESIDENT AND VICE PRESIDENT OF THE UNITED STATES

AND WHEREAS, the official certificates or returns of said election, held in the several counties of the said State, in due manner made out, signed and executed, have been delivered to me according to the laws of the said State, by the Superior Court of said counties; and having examined said returns, and enumerated and ascertained the number of votes for each and every candidate or person voted for as one of such Electors, the result appears as follows, to wit:


