KNOW BY ALL THESE PRESENT: That we, the undersigned, electors of President and Vice President of the United States of America, duly and legally elected and appointed as such on the 3rd day of November, 2020, or chosen as provided by law for the filling of vacancies of Presidential Electors by and for the State of Illinois, as appears by the annexed certificates made and delivered to us by the Illinois State Board of Elections

DO HEREBY CERTIFY that we met and convened, as provided by law at ten o'clock in the forenoon, in the Capitol, in the City of Springfield, in the State of Illinois, on the 14th day of December, 2020, being the first Monday after the second Wednesday in December next following our appointment, and organized

by electing Mayor Lori Lightfoot Chairperson and Don Harmon Secretary of the College of Electors of the State of Illinois; And we further certify that we then proceeded to vote by ballot, and voted first for President of the United States, and then for Vice President of the United States, by distinct ballots; and that the following are two distinct lists, one of the votes for President, and the other of the votes for Vice President, so case as aforesaid:
