CERTIFICATE OF ASCERTAINMENT OF PRESIDENTIAL ELECTORS

IN THE NAME AND BY THE AUTHORITY OF THE
COMMONWEALTH OF PENNSYLVANIA

Pursuant to the Laws of the United States, I, Tom Corbett, Governor of the Commonwealth of Pennsylvania, do hereby certify that in accordance with the provisions of the Pennsylvania Election Code, Act of June 3, 1937 (P.L. 1333, No. 320), the Secretary of the Commonwealth, on receiving and computing the returns of the election of Presidential Electors, shall lay them before the Governor, who shall enumerate and ascertain the number of votes given for each person so voted for, and shall cause a certificate of election to be delivered to each person so chosen. It appears from the returns so laid before me by the Secretary of the Commonwealth, that at an election for that purpose held on the Tuesday next following the first Monday in November, being the sixth day of November, A.D. 2012, the votes given for each person so voted for were:

have received the greatest number of votes for Electors of President and Vice President of the United States for the Commonwealth of Pennsylvania, and therefore are the persons duly elected and appointed Electors of President and Vice President of the United States, to meet at the seat of Government of this Commonwealth (being in the city of Harrisburg) on the first Monday after the second Wednesday in December next following their appointment, being the seventeenth day of December, A.D. 2012, agreeably to the laws of this Commonwealth and of the United States, then and there to vote for President and Vice President of the United States for the respective terms prescribed by the Constitution of the United States, to begin on the twentieth day of January, A.D. 2013, and to perform such other duties as devolve upon them under the Constitution and Laws of the United States.
