This Modification provides \$8,235,018.00 in additional funds under Option 1, (CLINs 0101AA, 0101AB, 0102AA, & 0102AB). Total contract funding increases from the not-to-exceed amount of \$54,305,945.68 by \$8,235,018.00 to \$62,540,963.68 (including \$53,154,018.00 NTE for Option 1), and remains subject to FAR 52.232-22, Limitation of Funds. Total Price, Estimated Cost and Fee, including all options, if exercised, remains \$317,436,051.68 pending final definitization of re-planning proposal.

The purpose of this modification is to increase the total available funding for Increment 1 from \$44,919,000 by \$8,235,018 to \$53,154,018. The additional funding is distributed to the following SubCLINs.
