14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

The purpose of Modification 00025 is three-fold:
First, Extend the Period of Performance for CLIN 0103 Option One Overrun (PRISM ITEM 0009) from 3/14/08 to 5/31/08; Second, Increase overrun funding under CLIN 0103 Option One Overrun (PRISM ITEM 0009) from \$9,450,285.52 by \$3,463,236.66 to \$12,913,522.18. (INTERNAL TRANSACTION REVISE SHIP TO # 2 and #6 by \$36,763.34); Third, increase Option I CLIN 0101AA (PRISM ITEM 0124) upward from \$51,662,825.00 by \$36,763.34 to \$51,699,588.34 (INTERNAL TRANSACTION ADD SHIP TO #4). Total contract funded amount and value is hereby increased from \$90,513,728.68 by \$3,500,000.00 to \$94,013,728.68. Total Overrun funding provided to date equals \$15,102,522.00 and includes \$12,913,522.18 under Option One Overrun Item 0103, and \$2,189,000.00 under Option I Development Item 0101AA.

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
