A. This Modification hereby increases funds for Option I Overrun CLIN 0103 (PRISM ITEM 0009) from \$12,913,522.18 by \$975,000.00 to \$13,888,522.18.

B. SUMMARY: Total Overrun funding provided to date is increased from \$15,102,522.00 by \$975,000.00 to \$16,077,522.18. (\$13,888,522.18 under Item 0103, and \$2,189,000.00 under Item 0101AA). Total funded amount and estimated value of this contract is hereby increased from \$101,513,728.68 by \$975,000.00 to \$102,488,728.68.
