Dear Mr. Cipollone:

In accordance with the requirements of the Presidential Records Act (PRA), as amended, 44 U.S.C. §§2201-2209, this letter constitutes a formal notice from the National Archives and Records Administration (NARA) to the incumbent President of our intent to open George H.W. Bush Presidential records in response to the systematic processing projects and Freedom of Information Act (FOIA) requests listed in Attachment A.

This material, consisting of 115,197 pages, has been reviewed for all applicable FOIA exemptions, resulting in a total of 19,575 pages restricted. NARA is proposing to open the remaining 95,622 pages. A copy of any records proposed for release under this notice will be provided to you upon your request.

Pursuant to 44 U.S.C. 2208(a), NARA will release the records 60 working days from the date of this letter, which is December 31, 2019, unless the incumbent President requests a one-time extension of an additional 30 working days or asserts a constitutionally based privilege, in accordance with 44 U.S.C. 2208(b)-(d). Please let us know if you are able to complete your review before the expiration of the 60 working day period. Pursuant to 44 U.S.C. 2208(a)(1)(B), we will make this notice available to the public on the NARA website.

These materials concern US-Chinese relations and include declassified or unclassified cables with general background on topics such as human rights, general Chinese foreign policy, Japan, the USSR, the Gulf War, and trade or travel information

from the State Department; letters to and from members of Congress concerning human rights issues in China; declassified memoranda of conversation between US and Chinese officials ranging in dates from 1978 to 1980; talking points on trade issues with China; papers from interest groups and businesses on commercial satellites and non-proliferation, as well as background papers for meetings with Chinese leaders. There are also resumes for nominees to the Commission on Broadcasting to the People's Republic of China.

There are a number of previously declassified memoranda of conversations between President Bush and world leaders while he was in Japan. Tabs are used to organize the material.

These records contains information related to the transition from the Reagan Administration to the Bush Administration. The manuals and correspondence contain guidelines and instructions for important processes within the NSC such as records management, handling classified information, descriptions of NSC duties, speechwriting, reports to Congress, and foreign travel. Also included are statutes and presidential directives from previous administrations establishing the basic organization and operations of the NSC.

The Library has completed the systematic processing of files created and collected by Philip Zelikow of the National Security Council. The Bush Presidential records proposed for opening are cables, cover sheets, correspondence, press releases, and papers. The cables are declassified or unclassified and contain communication of U.S. policy to delegations at meetings with European countries, as well as news articles and transcripts of press conferences. The cover sheets contain basic routing information. Internal administrative correspondence discusses issues such as meeting and travel arrangements. Correspondence with Congress and with the public

relates to European issues including German Reunification, US forces in Europe, and various treaties (CFE, COCOM, START, etc). Also enclosed are declassified transcripts from meetings and telephone conversations with European leaders. The press releases provide guidance and Q&As on treaties, environmental issues, and other international matters related to Europe and the Former Soviet Union. Declassified and unclassified papers from the administration, Congress, and private organizations discuss deterrence, weapons modernization, nuclear testing, security policy, science and technology cooperation, and NATO accomplishments.
