Dear Mr. McGahn:

In accordance with the requirements of the Presidential Records Act (PRA), as amended, 44 U.S.C. §§2201-2209, this letter constitutes a formal notice from the National Archives and Records Administration (NARA) to the incumbent President of our intent to open George W. Bush Presidential records in response to the Freedom of Information Act (FOIA) requests listed in Attachment A.

This material, consisting of 32,575 pages and 30,362 assets, has been reviewed for the six PRA Presidential restrictive categories, including confidential communications requesting or submitting advice (P5) and material related to appointments to federal office (P2), as they were eased by President George W. Bush on November 15, 2010. These records were also reviewed for all applicable FOIA exemptions. As a result of this review, 10,693 pages and 11,157 assets in whole, and 3,338 pages and 2,416 assets in part have been restricted. Therefore, NARA is proposing to open the remaining 18,544 pages and 16,789 assets in whole and 3,338 pages and 2,416 assets in part that do not require closure under 44 U.S.C. § 2204. A copy of any records proposed for release under this notice will be provided to you upon your request.

We are also concurrently informing former President George W. Bush's representative, Tobi Young, of our intent to release these records. Pursuant to 44 U.S.C. 2208(a), NARA will release the records 60 working days from the date of this letter, which is September 1, 2017, unless the former or incumbent President requests a one-time extension of an additional 30 working days or asserts a constitutionally based privilege, in accordance with 44 U.S.C. 2208(b)-(d). Please let us know if you are able to complete your review before the expiration of the 60 working day period. Pursuant to 44 U.S.C. 2208(a)(1)(B), we will make this notice available to the public on the NARA website.

The George W. Bush Presidential textual records proposed for opening are limited to a list of folder titles related to the unauthorized disclosure of classified information. The majority of responsive folder titles are from the White House Counsel's Office, the Office of Administration, and the White House Office of Records Management. Electronic records proposed for opening are news clippings and press briefing transcripts related to Valerie Plame Wilson, correspondence with journalists regarding the Plame investigation and subsequent court cases, correspondence with members of the general public about the Plame investigation, publicly available documents relating to Congressional hearings and investigations, and publicly filed documents in various court cases related to Valerie Plame Wilson. The court cases include: In Re: Grand Jury Subpoena, Judith Miller; United States v. I. Lewis Libby Jr.; Valerie Plame Wilson, *et al.* v. I. Lewis Libby Jr., *et al.*; Committee on the Judiciary of the United States House of Representatives v. Harriet Miers and Joshua B. Bolten; and Citizens for Responsibility and Ethics in Washington v. Executive Office of the President, *et al.* Also included are press pool reports, talking points, invitations to public events, excerpts from published reports, lists of FOIA requests pending at Executive Branch agencies, letters from members of Congress and summaries thereof, lists of upcoming legislative activities, and questions for the record submitted by members of Congress to individuals nominated for office or to the judiciary. These records date between January 1, 2003 and January 20, 2009 and are from the Automated Records Management System (ARMS), Exchange Email, Exchange Email – Restored – 21 Days, Exchange Email – Restored – 33 Days, Exchange Email – Restored – 40 Days, and RNC Personal Storage Table (PST) Search and Access Sets.

This researcher submitted a Freedom of Information Act (FOIA) request for records related to the housing and credit crisis of 2008-2009, limited to information or correspondence with the Securities and Exchange Commission (SEC), the Financial Industry Regulatory Authority (FINRA), the U.S. Commodity Futures Trading Commission (CFCT), Christopher Dodd, or Barney Frank. The George W. Bush Presidential textual records proposed for opening are letters from Christopher Dodd and other senators to President George W. Bush regarding the housing crisis. These materials are from the White House Office of Records Management Subject Files. Electronic records proposed for opening consist of articles, talking points, fact sheets, press releases, Q & As, agendas, speech drafts, testimony and remarks, legislation and drafts thereof, and routine informational and enrolled bill memoranda. Testimony and remarks come from Chairman Christopher Cox of the SEC and Chairman Bernanke of the Federal Reserve Board, as well as press releases with remarks from Senator Christopher Dodd. Additionally, there are agendas for meetings of the Interagency Financial Markets Group and the President’s Working Group. White House Q & As, press releases, fact sheets, and speeches relate to credit and housing markets and the economy. Also included are summaries of legislation and draft and final versions of legislation and amendments to legislation such as the Emergency Economic Stabilization Act of 2008. Finally, there is an information memorandum entitled “The Involvement of Fannie Mae and Freddie Mac in Various Aspects of the Mortgage Market” for Edward Lazear, and a routine enrolled bill memoranda for President George W. Bush regarding H.R. 1424, the Emergency Economic Stabilization Act of 2008. Bush and Andy Card from individuals and organizations including meeting requests, requests for assistance, and invitations. Also included are articles, press releases, and reports sent from organizations. Additionally, a 2002 report on Sudan from the U.S. Commission on International Religious Freedom is present. There is also correspondence with Laura Unger, SEC Chairman, regarding the long-term lease of property, the transmittal of reports from the SEC and Securities Investor Protection Corporation, and a White House tour request. In addition, there are routine memoranda, orders, and press releases regarding the designation of Laura Unger as Acting Chairman of the SEC and also the transmittal of her resignation from the SEC. Electronic records proposed for opening consist of news clippings, newsletters, correspondence confirming President George W. Bush's appointment of Laura Unger as Acting Chairman of the SEC, invitations to public events, summaries of upcoming Congressional activities, phone lists, talking points, excerpts of the Congressional Record related to the No Child Left Behind Act, comments from interest groups on proposed regulations, scheduling proposals for photographs with President George W. Bush, routine administrative correspondence, and routine correspondence about the resignation of government officials. Included is President George W. Bush’s June 15-16, 2001 trip to Warsaw, Poland. Photographs show an arrival ceremony at the Presidential Palace, meetings and a press availability with President Aleksandar Kwasniewski, meetings with Prime Minister Jerzy Buzek, as well as wreath laying ceremonies at the Tomb of the Unknown Soldier, the Warsaw Ghetto Memorial and the Home Army Memorial. Also included are photos from an address by President George W. Bush at Warsaw University, a State Dinner, and an embassy greeting. Additional photographs depict Mrs. Laura Bush visiting a children’s hospital, the Lauder Morasha School, an orphanage, and the Nozyk Synagogue as well as events with Mrs. Jolanta Kwasniewska. Photographs from domestic trips show a tour and remarks on the economy at John Deere Harvester Works in Moline, IL on January 14, 2002; a meeting with faith leaders in St. Louis, MO on March 18, 2002; and a roundtable with small business owners and remarks to employees at Albers Manufacturing Company, Inc. in O’Fallon, MO on March 18, 2002. Also depicted are a visit to Pierre Laclède Elementary School in St. Louis, MO on January 5, 2004 where President George W. Bush visited with 4th grade students in the school library and attended an event on No Child Left Behind. Lastly, there are photographs of a tour and remarks at the Abraham Lincoln Presidential Library and Museum Dedication in Springfield, IL on April 19, 2005. These materials are from the White House Photo System – Presidential Search and Access Set.

Electronic records proposed for opening consist of spreadsheets tracking the confirmation process of judicial nominees, lists of the minority judges

In accordance with the requirements of the Presidential Records Act (PRA), as amended, 44 U.S.C. §§2201-2209, this letter constitutes a formal notice from the National Archives and Records Administration (NARA) to you, as former President George W. Bush's representative, of our intent to open George W. Bush Presidential records. These records were processed under the systematic processing projects and Freedom of Information Act (FOIA) requests described in Attachment A.

These records, consisting of 32,575 pages and 30,362 assets, have been reviewed for the six PRA Presidential restrictive categories, including confidential communications requesting or submitting advice (P5) and material related to appointments to federal office (P2), as they were eased by President George W. Bush on November 15, 2010. These pages were also reviewed for all applicable FOIA exemptions. As a result of this review, NARA has restricted 10,693 pages and 11,157 assets in whole, and 3,338 pages and 2,416 assets in part. NARA is proposing to open the remaining 18,544 pages and 16,789 assets in whole and 3,338 pages and 2,416 assets in part that do not require closure under 44 U.S.C. § 2204. A copy of any records proposed for release under this notice will be made available to you upon your request.

We are also concurrently informing the incumbent President of our intent to release these George W. Bush Presidential records. Pursuant to 44 U.S.C. 2208(a), NARA will release the records 60 working days from the date of this letter, which is September 1, 2017, unless the former or incumbent President requests a one-time extension of an additional 30 working days or asserts a constitutionally based privilege, in accordance with 44 U.S.C. 2208(b)-(d). Please let us know if you are able to complete your review before the expiration of the 60 working day period. Pursuant to 44 U.S.C. 2208(a)(1)(B), we will make this notice available to the public on the NARA website.
