Dear Mr. McGahn:

In accordance with the requirements of the Presidential Records Act (PRA), as amended, 44 U.S.C. §§2201-2209, this letter constitutes a formal notice from the National Archives and Records Administration (NARA) to the incumbent President of our intent to open George W. Bush Presidential records in response to the systematic processing projects and Freedom of Information Act (FOIA) requests listed in Attachment A.

This material, consisting of 80,937 pages, 4,689 assets, and 19 video clips, has been reviewed for the six PRA Presidential restrictive categories, including confidential communications requesting or submitting advice (P5) and material related to appointments to federal office (P2), as they were eased by President George W. Bush on November 15, 2010. These records were also reviewed for all applicable FOIA exemptions. As a result of this review, 12,560 pages and 2,522 assets withheld in whole and 3,603 pages, 195 assets, and 2 video clips withheld in part have been restricted. Therefore, NARA is proposing to open the remaining 64,774 pages, 1,972 assets and 17 video clips in whole and 3,603 pages, 195 assets, and 2 video clips in part that do not require closure under 44 U.S.C. § 2204. A copy of any records proposed for release under this notice will be provided to you upon your request.

We are also concurrently informing former President George W. Bush's representative, Tobi Young, of our intent to release these records. Pursuant to 44 U.S.C. 2208(a), NARA will release the records 60 working days from the date of this letter, which is January 15, 2018, unless the former or incumbent President requests a one-time extension of an additional 30 working days or asserts a constitutionally based privilege, in accordance with 44 U.S.C. 2208(b)-(d). Please let us know if you are able to complete your review before the expiration of the 60 working day period. Pursuant to 44 U.S.C. 2208(a)(1)(B), we will make this notice available to the public on the NARA website.

Bush Presidential textual records proposed for opening are schedules, briefing papers, schedule proposals, site surveys, printed emails, articles, maps, internet printouts, published materials, talking points, Q&As, pool reports, fact sheets, handwritten notes, thank you letters, copies of signed photos, cables, maps, lists, fax cover sheets, receipts, forms, and other administrative documents. There are numerous versions of schedules for Mrs. Bush's travels from July 8-15, 2005, scheduling proposals and background materials on the various organizations visited during the trip, and other administrative prep materials related to the planning of the trip such as scheduling information for the site survey team and menus for air travel. Also included are printed administrative emails and documentation regarding Rick and Kay Warren and Cherie Blair's travels to Africa at the same time as Mrs. Bush's. Draft and final letters to the editor of AllAfrica.com from Kristen Silverberg regarding Mrs. Bush's comments about the ABC model of HIV prevention are also present. Lastly, there are schedules, Q&As, administrative documents, and other background materials related to President George W. Bush and Laura Bush's travel to the G-8 Summit in Gleneagles, Scotland, as Mrs. Bush left for Africa directly from this event. These materials are from the White House Office of Records Management Subject Files and the Office of Laura Bush. Electronic records proposed for opening consist of emails that contain press schedules, final drafts of speeches delivered on the trip, news articles with commentary, transcripts of Mrs. Bush's remarks and an interview with Ann Curry for the TODAY Show, pool reports, speeches delivered by Ambassador Randall Tobias regarding HIV/AIDS, interview requests from reporters, and briefing papers for trip events. There are emails

requesting the posting of transcripts of remarks and photographs with captions on the White House website, copies of the transcripts and photos, as well as status reports on the website update. Also included is an email discussing the ability of the Treasury Department to provide briefing materials and a response from a staff member in Mrs. Bush's Office. Documents from the shared drives include a list of individuals to thank, press proposals, and spreadsheets containing photo captions for the White House website. These electronic records are from the Exchange Email, NSC Shared Drive, OA Shared Drive, and WHO Shared Drive Search and Access Sets.

In accordance with the requirements of the Presidential Records Act (PRA), as amended, 44 U.S.C. §§2201-2209, this letter constitutes a formal notice from the National Archives and Records Administration (NARA) to you, as former President George W. Bush's representative, of our intent to open George W. Bush Presidential records. These records were processed under the Freedom of Information Act (FOIA) requests described in Attachment A.

These records, consisting of 80,937 pages, 4,689 assets, and 19 video clips, have been reviewed for the six PRA Presidential restrictive categories, including confidential communications requesting or submitting advice (P5) and material related to appointments to federal office (P2), as they were eased by President George W. Bush on November 15, 2010. These pages were also reviewed for all applicable FOIA exemptions. As a result of this review, NARA has restricted 12,560 pages and 2,522 assets withheld in whole and 3,603 pages, 195 assets, and 2 video clips withheld in part. NARA is proposing to open the remaining 64,774 pages, 1,972 assets and 17 video clips in whole and 3,603 pages, 195 assets, and 2 video clips in part that do not require closure under 44 U.S.C. § 2204. A copy of any records proposed for release under this notice will be made available to you upon your request.

We are also concurrently informing the incumbent President of our intent to release these George W. Bush Presidential records. Pursuant to 44 U.S.C. 2208(a), NARA will release the records 60 working days from the date of this letter, which is January 15, 2018, unless the former or incumbent President requests a one-time extension of an additional 30 working days or asserts a constitutionally based privilege, in accordance with 44 U.S.C. 2208(b)-(d). Please let us know if you are able to complete your review before the expiration of the 60 working day period. Pursuant to 44 U.S.C. 2208(a)(1)(B), we will make this notice available to the public on the NARA website.
