Dear Mr. Cipollone:

In accordance with the requirements of the Presidential Records Act (PRA), as amended, 44 U.S.C. §§2201-2209, this letter constitutes a formal notice from the National Archives and Records Administration (NARA) to the incumbent President of our intent to open George W. Bush Presidential records in response to the Freedom of Information Act (FOIA) requests listed in Attachment A.

This material, consisting of 142,854 pages, 6,620 assets, and 31 video clips, has been reviewed for the six PRA Presidential restrictive categories, including confidential communications requesting or submitting advice (P5) and material related to appointments to federal office (P2), as they were eased by President George W. Bush on November 15, 2010. These records were also reviewed for all applicable FOIA exemptions. As a result of this review, 87,265 pages, 3,811 assets, and 8 video clips in whole and 3,004 pages, 346 assets, and 2 video clips in part have been restricted. Therefore, NARA is proposing to open the remaining 52,585 pages, 2,463 assets, and 21 video clips in whole and 3,004 pages, 346 assets, and 2 video clips in part that do not require closure under 44 U.S.C. § 2204. A copy of any records proposed for release under this notice will be provided to you upon your request.

We are also concurrently informing former President George W. Bush's representative, Freddy Ford, of our intent to release these records. Pursuant to 44 U.S.C. 2208(a), NARA will release the records 60 working days from the date of this letter, which is July 11, 2019, unless the former or incumbent President requests a one-time extension of an additional 30 working days or asserts a constitutionally based privilege, in accordance with 44 U.S.C. 2208(b)-(d). Please let us know if you are able to complete your review before the expiration of the 60 working day period. Pursuant to 44 U.S.C. 2208(a)(1)(B), we will make this notice available to the public on the NARA website.

The majority of this request consists of briefing book and trip book materials related to the trip President George W. Bush took to Europe in February 2005. These briefing and trip book materials include scene setting reports on the places President George W. Bush visited, schedules, press availabilities, talking points, and Q&As. These materials are from the National Security Council, the White House Office of Appointments and Scheduling, the White House Office of the Staff Secretary, and the White House Office of Records Management. Electronic records proposed for opening consist of articles, schedules, final remarks, press briefings, a Q&As, and photos and text for the White House website regarding President George W. Bush's trip to Europe in February 2005. These electronic records are from the Exchange Email, Exchange Email Restored - 33 Days, Exchange Email Restored - 40 Days, RNC Personal Storage Table (PST), NSC Shared Drive, OA Shared Drive, and WHO Shared Drive Search and Access Sets.

This researcher submitted a Freedom of Information Act (FOIA) request for records related to the drafting of the USA PATRIOT Act of 2001. The George W. Bush Presidential textual records proposed for opening consist of draft legislation, general correspondence, routing memoranda, speeches and drafts thereof. Also included are Congressional Research Service (CRS) reports, briefing materials, transcripts of testimony before Congress, and schedule proposals. These materials are from the White House Counsel's Office, the Homeland Security Council, the National Security Council, and the White House Office of Records Management (WHORM) Subject Files. Electronic records proposed for opening consist of draft legislation, final Statements of Administration Policy, Congressional Research Service (CRS) reports, Legislative Referral Memoranda (LRM), general correspondence, as well as Presidential remarks. In addition, there are schedule proposals and briefings regarding the bill signing ceremony, along with supporting documents such as participant lists, WAVES records, and photographs. Also included in this request are congressional materials, such as Daily Whip Alerts, schedules of the House Rules Committee, and published statements on the legislation from Congressmen. All personally identifiable information present in these records has been withheld. These records come from the Automated Records Management System (ARMS), RNC Personal Storage Table (PST), CEA Shared Drive, NSC Shared Drive, and OPD Shared Drive Search and Access Sets.

This researcher submitted a Freedom of Information Act (FOIA) request for records on the April 6-7, 2002 meetings between President George W. Bush and British Prime Minister Tony Blair. The George W. Bush Presidential textual records proposed for opening are schedules and drafts thereof, routine memoranda, biographies, transcripts of remarks and radio addresses, and webpage printouts.

The bulk of this material consists of schedules of President George W. Bush and routine staffing memoranda. Included are materials related to the 2002 White House Easter Egg Roll and a copy of “Good Start, Grow Smart: The Bush Administration’s Early Childhood Initiative.” These materials are from the White House Office of Records Management Subject Files (WHORM), the National Security Council, the White House Office of Speechwriting, the White House Office of the Staff Secretary, and the White House Office of Strategic Initiatives. Electronic records proposed for opening consist of schedules, pool reports, transcripts of interviews and press gaggles, and drafts of talking points and remarks. These electronic records come from the Automated Records Management System (ARMS), NSC Shared Drive, and WHO Shared Drive Search and Access Sets.

Bush Presidential textual records proposed for opening include correspondence (mostly to or from members of Congress), White House memoranda, speeches, statements, legislation, transcripts from open Congressional hearings, news articles, reports (both administration-produced and from outside organizations), and scheduling materials. These records are from the White House Office of Records Management Subject Files and White House Office of the Staff Secretary. The George W. Bush Presidential audiovisual records proposed for opening consist of audio and video clips of routine events, photo opportunities and remarks by President George W. Bush, including remarks to Central Intelligence Agency employees. The audiovisual records are from the White House Communications Agency.

This researcher submitted a Freedom of Information Act (FOIA) request for records sent to, sent by, or received by President George W. Bush related to Iraq and Saddam Hussein, from January 2001 to March 2003. The George W. Bush Presidential records proposed for opening are cover sheets, routing memoranda, printed routing emails, advance schedules and briefings, talking points, unclassified memoranda of conversation, unclassified head of state correspondence, press points, publications (including Iraqi publications), Congressional transcripts, letters to and from members of Congress, letters from public organizations, and periodic reports to Congress, such as the periodic report on the National Emergency with Respect to Iraq and the Report to Congress Consistent with Authorization for Use of Military Force Against Iraq Resolution of 2002. The correspondence from members of Congress include letters regarding UN inspections, complying with United Nations Security Council Resolution 1441, and questions about periodic reports. Additionally, this FOIA includes bills, charts, maps, a declassified summary of conclusions from March 19, 2003, where President George W. Bush names Operation Iraqi Freedom, drafts of United Nations Security Council Resolutions, and drafts of the Joint Resolution to use Armed Forces Against Iraq (Authorization for Use of Force Against Iraq Resolution of 2002). Also covered in this request are routine memoranda of conversations and memoranda of telephone conversations, some of which are marked unclassified and others which have been declassified under mandatory declassification review. These include conversations with Prime Minister Anders Fogh Rasmussen of Denmark, President Pervez Musharraf of Pakistan, Sultan bin Said Qaboos of Oman, King Hamad bin Isa al-Khalifa of Bahrain, among others. In addition, there is routine head of state correspondence, some of which is marked unclassified and others which have been declassified under mandatory declassification review. These include correspondence with Prime Minister Jose Maria Aznar of Spain, Prime Minister Fatos Nano of Albania, the Prime Minister of Kuwait, President Vaclav Havel, among others. These materials are from the White House Counsel's Office and the National Security Council.

The George W. Bush Presidential records proposed for opening are cables, correspondence, cover sheets, distribution receipts, forms, lists, messages, National Security Council Profile Sheets, news and journal articles, press briefings and press releases, Q&As, reports, speech drafts, barcode scanning sheets, administrative routing documents, routine printed emails, and statements. This FOIA primarily contains ceremonial correspondence and thank you notes between President George W. Bush and various Saudi representatives including Crown Prince Abdullah and Saudi ambassador Bandar bin Sultan; a transcript of an interview between press and a senior administration official on April 23, 2002; correspondence with members of Congress on various issues relating to Saudi Arabia and United States relations; transmittal memoranda (snowflakes) with attached news articles from Secretary of Defense Donald Rumsfeld to President George W. Bush; reports containing factual information on the Middle East peace process; drafts of various speeches that mention Saudi Arabia; letters to President George W. Bush soon after the 9/11 terrorist attacks; a memorandum regarding the status of the confirmation of ambassadors; and four memoranda of telephone conversations declassified under mandatory review between President George W. Bush and Crown Prince Abdullah of Saudi Arabia, President Mubarak of Egypt, and King Abdullah of Jordan. These materials are from the National Security Council, the White House Office of the Staff Secretary, and the White House Office of Records Management.

The George W. Bush Presidential textual records proposed for opening are general correspondence, routing memoranda, reports and printed material. Included are copies of President George W. Bush's February 7, 2002 memorandum "Humane Treatment of al Qaeda and Taliban Detainees," condolence letters from Prince Bandar bin Sultan and King Fahd bin Abdulaziz Al-Saud, a Federal Register notice regarding Executive Order 13224, copies of both the "National Strategy for Combating Terrorism" and "9/11 Five Years Later: Successes and Challenges" and a transcript of Ari Fleischer's August 28, 2002 press gaggle regarding Prince Bandar bin Sultan's visit to Crawford, TX. Included are a South Lawn arrival via Marine One, photo ops with boxer Johnny Ruiz and Teacher of the Year Kathy Black, a meeting with the Saudi Ambassador to the United States, a meeting with the Foreign Minister of Saudi Arabia, and a Hanukkah reception. Also included is b-roll footage of damaged areas after the September 11th terrorist attacks, including Ground Zero on 9/19/2001 and the Pentagon on 9/11/2001 and 9/14/2001. These videos are from the White House Communications Agency, WHTV and the White House Office of Communications, Scott Sforza.

This researcher submitted a Freedom of Information Act (FOIA) request for records from the National Security Council related to the invasion and subsequent fall of Baghdad to American troops on April 9, 2003. The George W. Bush Presidential textual records proposed for opening are books, cables, charts, correspondence, cover sheets, distribution receipts, forms, lists, maps, messages, National Security Council Profile Sheets, news and journal articles, press briefings and press releases, resolutions, reports, schedules, speech drafts, administrative routing documents, routine printed emails, statements, talking points, and timelines. This FOIA primarily contains material related to weapons of mass destruction, Iraqi regime change, foreign media reports on the United States relations with Iraq, the use of military force against Iraq in 2003, and reconstruction and humanitarian aid in Iraq. These materials come in the form of news sources, unclassified cables, timelines, reports to Congress, a number of unclassified white papers, and open source reports. These reports are from several sources including the National Intelligence Council, the United States Department of State Bureau of Intelligence and Research, and the Council on Foreign Relations. This FOIA also includes timelines on United Nations sanctions against Iraq, United States relations with Iraq, and Operation Iraqi Freedom; fact sheets, press releases and reactions in the press to the United States invasion of Iraq; and materials on the reconstruction process in Iraq after the invasion, including several daily updates from the Office for Reconstruction and Humanitarian Assistance (ORHA). Additionally, there are statements about weapons of mass destruction in Iraq before the United Nations Security Council by Mohamed ElBaradei and Hans Blix, along with testimony before the Senate Armed Services Committee on the use of military force against Iraq by United States Secretary of Defense Donald Rumsfeld, General Tommy Franks, and Under Secretary of Defense for Policy Douglas Feith. Lastly, this FOIA also contains copies of an interview Secretary of State Colin Powell gave to Sir David Frost in August 2002. These materials are from the National Security Council. Electronic records proposed for opening consist of routine emails, summaries of media coverage regarding the war in Iraq, news articles and op-eds regarding the war in Iraq, summaries of public polling, and a presentation on civil-military relations. These electronic records are from the Automated Records Management System (ARMS), Exchange Email, and NSC Shared Drive Search and Access Sets.

Electronic records proposed for opening consist of fact sheets, articles, Q&As, talking points, radio addresses, final testimony, schedules and pool reports. These materials relate to a scheduled meeting at Camp David in which President George W. Bush was to have a video conference with Prime Minister Maliki in Iraq; however, President George W. Bush made a surprise visit to Iraq to meet with the Prime Minister instead. Materials include a final Q&A prior to the Camp David meetings, a final fact sheet at the conclusion of the meetings entitled "Camp David Meetings: Building on Progress in Iraq," articles and pool reports related to the surprise visit, and schedules for the Camp David meetings. Additionally, there are talking points, articles, and other published materials regarding the death of Abu Musab al-Zarqawi; final testimony by Ambassador James F. Jeffrey on Iraq after the Camp David meetings; and a radio address by President George W. Bush from June 17, 2006. These electronic records are from the Exchange Email and NSC Shared Drive Search and Access Sets.

Correspondence includes letters and holiday cards from Margaret Thatcher to President George W. Bush and Laura Bush; a letter from President George W. Bush to Thatcher regarding the withdrawal of the United States from the 1972 ABM Treaty; a letter from President George W. Bush to Thatcher upon the death of her husband, Dennis; the draft and final versions of a letter from President George W. Bush to Cardinal Delly modeled after a letter sent to Thatcher, as well as background material; congratulatory letters from heads of state and leaders to President George W. Bush upon his reelection in 2004; holiday cards seen by Laura Bush including cards from Queen Elizabeth II, Prime Minister Tony Blair, Prime Minister John Howard, and other leaders on the national and international level; and invitations and other correspondence from various individuals and organizations to Andrew Card, Joshua Bolten, and Karl Rove. Also included

are a memorandum to Rove recommending a phone call to Thatcher on her birthday, the Presidential Daily Diary for December 10, 2002 and a May 2, 2001 statement from Margaret Thatcher following the announcement of President George W. Bush of his plans to develop a system of global ballistic missile defense. Lastly, there are documents regarding Rove's speaking engagement honoring Thatcher at The Heritage Foundation on September 12, 2006 including the invitation, scheduling details, and background research on Thatcher. In accordance with the requirements of the Presidential Records Act (PRA), as amended, 44 U.S.C. §§2201-2209, this letter constitutes a formal notice from the National Archives and Records Administration (NARA) to you, as former President George W. Bush's representative, of our intent to open George W. Bush Presidential records. These records were processed under the Freedom of Information Act (FOIA) requests described in Attachment A.

These records, consisting of 142,854 pages, 6,620 assets, and 31 video clips have been reviewed for the six PRA Presidential restrictive categories, including confidential communications requesting or submitting advice (P5) and material related to appointments to federal office (P2), as they were eased by President George W. Bush on November 15, 2010. These pages were also reviewed for all applicable FOIA exemptions. As a result of this review, NARA has restricted 87,265 pages, 3,811 assets, and 8 video clips in whole and 3,004 pages, 346 assets, and 2 video clips in part. NARA is proposing to open the remaining 52,585 pages, 2,463 assets, and 21 video clips in whole and 3,004 pages, 346 assets, and 2 video clips in part that do not require closure under 44 U.S.C. § 2204. A copy of any records proposed for release under this notice will be made available to you upon your request.

We are also concurrently informing the incumbent President of our intent to release these George W. Bush Presidential records. Pursuant to 44 U.S.C. 2208(a), NARA will release the records 60 working days from the date of this letter, which is July 11, 2019, unless the former or incumbent President requests a one-time extension of an additional 30 working days or asserts a constitutionally based privilege, in accordance with 44 U.S.C. 2208(b)-(d). Please let us know if you are able to complete your review before the expiration of the 60 working day period. Pursuant to 44 U.S.C. 2208(a)(1)(B), we will make this notice available to the public on the NARA website.
