Dear Mr. Warrington:

In accordance with the requirements of the Presidential Records Act (PRA), as amended, 44 U.S.C. §§2201-2209, this letter constitutes a formal notice from the National Archives and Records Administration (NARA) to the incumbent President of our intent to open George W. Bush Presidential records in response to the systematic processing projects and Freedom of Information Act (FOIA) requests listed in Attachment A.

These records, consisting of 85,201 pages, 2,129 assets, and 2 video clips have been reviewed for all applicable FOIA exemptions, resulting in 5,372 pages and 48 assets restricted in whole and 2,725 pages and 1 asset restricted in part. NARA is proposing to open the remaining 77,104 pages, 2,080 assets, and 2 video clips in whole, and 2,725 pages and 1 asset in part. A copy of any records proposed for release under this notice will be provided to you upon your request.

We are also concurrently informing former President George W. Bush's representative, Freddy Ford, of our intent to release these records. Pursuant to 44 U.S.C. 2208(a), NARA will release the records 60 working days from the date of this letter, which is August 15, 2025, unless the former or incumbent President requests a one-time extension of an additional 30 working days or asserts a constitutionally based privilege, in accordance with 44 U.S.C. 2208(b)-(d). Please let us know if you are able to complete your review before the expiration of the 60 working day period. Pursuant to 44 U.S.C. 2208(a)(1)(B), we will make this notice available to the public on the NARA website.

This researcher submitted a Freedom of Information Act (FOIA) request for records sent to, sent by, or received by, President George W. Bush on the dismissal of nine United States Attorneys between January 2005 and December 2007. The George W. Bush Presidential textual records proposed for opening consist of production documents provided to Congress and the Department of Justice per subpoena requests for testimony and/or records. A vast majority of the production documents consist of email printouts from the Exchange Email system. The email printouts and other textual correspondence between the White House and Congress pertains to White House staffers including Harriet Miers, Karl Rove, Fred Fielding, and Emmett Flood. The email printouts constitute the back and forth between staffers regarding the proposed dismissal or replacement of United States Attorneys in November and December 2006 specifically. They discuss the proposed plan and means for dismissal of Attorneys; the roles played by specific Administration staff; the House and Senate Judiciary Committees investigations; as well as nomination selections and pertinent information. Most of the email printouts are repetitive. There is textual correspondence between Congress and Department of Justice officials, including Attorneys General Alberto Gonzales and Michael Mukasey, and Solicitor General Paul Clement. There is back and forth communication between staffers about White House claims of executive privilege and include final memorandums from President George W. Bush who asserted executive privilege in response. Also present within the textual production documents are talking points and statements, news articles and press releases, Congressional hearing transcripts and reports, and published Presidential records. The vast majority of the records proposed for opening come from the White House Counsel's Office. The George W. Bush Presidential audiovisual records proposed for opening consist of two video clips of a farewell reception for Karl Rove on September 14, 2007. The audiovisual records are from the White House Communications Agency.

In accordance with the requirements of the Presidential Records Act (PRA), as amended, 44 U.S.C. §§2201-2209, this letter constitutes a formal notice from the National Archives and Records Administration (NARA) to you, as former President George W. Bush's representative, of our intent to open George W. Bush Presidential records. These records were processed under the systematic processing projects and Freedom of Information Act (FOIA) requests described in Attachment A.

These records, consisting of 85,201 pages, 2,129 assets, and 2 video clips have been reviewed for all applicable FOIA exemptions, resulting in 5,372 pages and 48 assets restricted in whole and 2,725 pages and 1 asset restricted in part. NARA is proposing to open the remaining 77,104 pages, 2,080 assets, and 2 video clips in whole, and 2,725 pages and 1 asset in part. A copy of any records proposed for release under this notice will be provided to you upon your request.

We are also concurrently informing the incumbent President of our intent to release these George W. Bush Presidential records. Pursuant to 44 U.S.C. 2208(a), NARA will release the records 60 working days from the date of this letter, which is August 15, 2025, unless the former or incumbent President requests a one-time extension of an additional 30 working days or asserts a constitutionally based privilege, in accordance with 44 U.S.C. 2208(b)-(d). Please let us know if you are able to complete your review before the expiration of the 60 working day period. Pursuant to 44 U.S.C. 2208(a)(1)(B), we will make this notice available to the public on the NARA website.

They discuss the proposed plan and means for dismissal of Attorneys; the roles played by specific Administration staff; the House and Senate Judiciary Committees investigations; as well as nomination selections and pertinent information. Most of the email printouts are repetitive.
