Dear Mr. Warrington:

In accordance with the requirements of the Presidential Records Act (PRA), as amended, 44 U.S.C. §§2201-2209, this letter constitutes a formal notice from the National Archives and Records Administration (NARA) to the incumbent President of our intent to open George W. Bush Presidential records in response to the systematic processing projects and Freedom of Information Act (FOIA) requests listed in Attachment A.

These records, consisting of 25,948 pages, 14,479 assets, and 1 video clip have been reviewed for all applicable FOIA exemptions, resulting in 2,290 pages and 2,359 assets restricted in whole and 725 pages and 2,089 assets restricted in part. NARA is proposing to open the remaining 22,933 pages, 10,031 assets, and 1 video clip in whole, and 725 pages and 2,089 assets in part. A copy of any records proposed for release under this notice will be provided to you upon your request.

We are also concurrently informing former President George W. Bush's representative, Freddy Ford, of our intent to release these records. Pursuant to 44 U.S.C. 2208(a), NARA will release the records 60 working days from the date of this letter, which is November 13, 2025, unless the former or incumbent President requests a one-time extension of an additional 30 working days or asserts a constitutionally based privilege, in accordance with 44 U.S.C. 2208(b)-(d). Please let us know if you are able to complete your review before the expiration of the 60 working day period. Pursuant to 44 U.S.C. 2208(a)(1)(B), we will make this notice available to the public on the NARA website.

Bush Presidential electronic records proposed for opening are emails containing speech drafts, memoranda, talking points, fact sheets, news articles, reports, legislation, briefings, and transcripts. Speech drafts focusing on the Global War on Terror (GWOT) given by President George W. Bush, Vice President Richard Cheney, and Assistant to the President for Homeland Security Frances F. Townsend make up the bulk of the records. Also included are drafts of legislation regarding Congressional reauthorization of the Patriot Act and reform within the intelligence community. Additionally, there are interviews with senior White House officials that delve into national security issues and the GWOT, reactions to news articles on national security-related topics, three and five year updates on the GWOT, amicus briefs and other court documents for terrorism-related cases such as Hamdi v Rumsfeld, Padilla v Rumsfeld, and U.S. v. Binyam Muhammad, and transcripts of testimony given before Congress by White House and agency officials regarding terrorism, national security, and intelligence. Finally, the administration's 2004 "Record of Achievement" and 2006 "National Security Strategy of the United States of America," as well as the Department of State's "Country Reports on Terrorism 2005" can be found throughout the records. This includes drafts and edits to the documents as well as the effort to disseminate the reports across the federal government and into state governments, academia, and private enterprise. These materials are from the Automated Records Management System (ARMS), Exchange Email, Exchange Email Restored - 21 Days, Exchange Email Restored - 40 Days, and RNC Personal Storage Table (PST) Search and Access Sets.

There is correspondence from state and local leaders, organizations (including the USCCR), and individuals expressing concerns over or requesting presidential support for a variety of legislation, political policies, and regulations. Also included are materials regarding the controversy surrounding the seating of Peter Kirsanow to the USCCR, the expiration of the term of Valerie Wilson, and the opposition of Chairwoman Mary Frances Berry to Kirsanow's appointment. Additionally, there are letters received by the White House regarding public comments made by Kirsanow in July 2002 regarding the civil rights of Arab Americans. There are also many job application candidate files, including those of Peter Kirsanow, which are released for those who received positions, and unsolicited resumes. Bush's representative, of our intent to open George W. Bush Presidential records. These records were processed under the systematic processing projects and Freedom of Information Act (FOIA) requests described in Attachment A.

These records, consisting of 25,948 pages, 14,479 assets, and 1 video clip have been reviewed for all applicable FOIA exemptions, resulting in 2,290 pages and 2,359 assets restricted in whole and 725 pages and 2,089 assets restricted in part. NARA is proposing to open the remaining 22,933 pages, 10,031 assets, and 1 video clip in whole, and 725 pages and 2,089 assets in part. A copy of any records proposed for release under this notice will be provided to you upon your request.

We are also concurrently informing the incumbent President of our intent to release these George W. Bush Presidential records. Pursuant to 44 U.S.C. 2208(a), NARA will release the records 60 working days from the date of this letter, which is November 13, 2025, unless the former or incumbent President requests a one-time extension of an additional 30 working days or asserts a constitutionally based privilege, in accordance with 44 U.S.C. 2208(b)-(d). Please let us know if you are able to complete your review before the expiration of the 60 working day period. Pursuant to 44 U.S.C. 2208(a)(1)(B), we will make this notice available to the public on the NARA website.
