Dear Mr. Eggleston:

In accordance with the requirements of the Presidential Records Act (PRA), as amended, 44 U.S.C. §§2201-2209, this letter constitutes a formal notice from the National Archives and Records Administration (NARA) to the incumbent President of our intent to open Clinton Presidential records in response to the Freedom of Information Act (FOIA) requests listed in Attachment A.

These records, consisting of 53,420 pages, have been reviewed for all applicable FOIA exemptions, resulting in 22,412 pages restricted. NARA is proposing to open the remaining 31,008 pages. A copy of any records proposed for release under this notice will be provided to you upon your request.

We are also concurrently informing former President Clinton's representative, Bruce Lindsey, of our intent to release these records. Pursuant to 44 U.S.C. 2208(a), NARA will release the records 60 working days from the date of this letter, which is June 25, 2015, unless the former or incumbent President requests a one-time extension of an additional 30 working days or asserts a constitutionally based privilege, in accordance with 44 U.S.C. 2208(b)-(d). Please let us know if you are able to complete your review before the expiration of the 60 working day period. Pursuant to 44 U.S.C. 2208(a)(1)(B), we will make this notice available to the public on the NARA website.

Several documents deal with Iraq's noncompliance with U.N. Resolutions, which included ending its support for terrorism. Letters from President Clinton to Congress on the status of Iraq's compliance and statements to the U.N. Security Council by Madeleine Albright (May 17, 1994) and Bill Richardson (June 24, 1998) are included. Press releases and unclassified Department of State cables announcing Turkish military incursions into northern Iraq to fight the PKK, a terrorist organization, are also included.

A large number of cables are included dealing primarily with meetings with Canada to discuss the implementation of the Arctic Council. Also included are emails, consisting of correspondence, press releases, and statements related to the Arctic Council. In addition, there are materials regarding a presidential message to the Council and correspondence from states and groups regarding the Council.

This material, consisting of 53,420 pages, has been reviewed for all applicable FOIA exemptions, resulting in 22,412 pages restricted. NARA is proposing to open the remaining 31,008 pages. A copy of any records proposed for release under this notice will be provided to you upon your request.

We are also concurrently informing the incumbent President of our intent to release these Clinton Presidential records. Pursuant to 44 U.S.C. 2208(a), NARA will release the records 60 working days from the date of this letter, which is June 25, 2015, unless the former or incumbent President requests a one-time extension of an additional 30 working days or asserts a constitutionally based privilege, in accordance with 44 U.S.C. 2208(b)-(d). Please let us know if you are able to complete your review before the expiration of the 60 working day period. Pursuant to 44 U.S.C. 2208(a)(1)(B), we will make this notice available to the public on the NARA website.

The majority of the correspondence was sent in by judges, lawyers, etc. and was either directed to President Clinton or Counsel to the President (in most cases, Bernard Nussbaum). Also included is correspondence between Calabresi and Clinton, who both graduated from Yale Law School and exchanged routine greetings during the Clinton Administration. The records located in the White House Staff and Office Files pertained to the paperwork associated with Calabresi being considered for a judicial appointment (Calabresi was appointed as a judge to the US Court of Appeals Second Circuit 1994). Electronic records include routine email references to Calabresi as well as entries into the Electronic Daily Diary System and Worker and Visitor Entry System (WAVES).
