Dear Mr. Eggleston:

In accordance with the requirements of the Presidential Records Act (PRA), as amended, 44 U.S.C. §§2201-2209, this letter constitutes a formal notice from the National Archives and Records Administration (NARA) to the incumbent President of our intent to open Clinton Presidential records in response to the Freedom of Information Act (FOIA) requests listed in Attachment A.

These records, consisting of 4,507 photographs, have been reviewed for all applicable FOIA exemptions, resulting in 110 photographs restricted. NARA is proposing to open the remaining 4,397 photographs. A copy of any records proposed for release under this notice will be provided to you upon your request.

We are also concurrently informing former President Clinton's representative, Bruce Lindsey, of our intent to release these records. Pursuant to 44 U.S.C. 2208(a), NARA will release the records 60 working days from the date of this letter, which is September 8, 2016, unless the former or incumbent President requests a one-time extension of an additional 30 working days or asserts a constitutionally based privilege, in accordance with 44 U.S.C. 2208(b)-(d). Please let us know if you are able to complete your review before the expiration of the 60 working day period. Pursuant to 44 U.S.C. 2208(a)(1)(B), we will make this notice available to the public on the NARA website.

For processing purposes the case is broken into segments resulting in the processing photograph book binders. Each photograph contact sheet binder contains up to 100 photograph contact sheets. For this segment book 081 (September 27, 1993; September 29, 1993 through September 30, 1993) was processed. The Clinton Presidential records proposed for opening consist of photographs pertaining to arrivals, departures, meetings, ceremonies, press briefings, official phone calls, photo-ops, etc. involving President Clinton, Hillary Rodham Clinton, and staff for the time period processed.

The researcher submitted a Freedom of Information Act (FOIA) request for photographs of Donald Trump. The Clinton Presidential records proposed for opening include President Clinton greeting and talking with Donald Trump and others at Trump Towers in New York, NY on June 16, 2000; President Clinton attending the U.S. Open Tennis matches in Flushing, NY on September 8, 2000; and President Clinton greeting Donald Trump and family in a stadium suite during the tennis event. The events listed above were processed at the photograph contact sheet level. During the processing at the contact sheet level, additional photographs were processed and proposed to be opened, depicting events such as President Clinton greeting drivers and personnel at Trump Towers in New York; President Clinton viewing the U.S. Open Tennis Championship in New York; and President Clinton greeting dignitaries and guests at the U.S. Open.

The researcher submitted a Freedom of Information Act (FOIA) request for photographs related to movie screenings attended by President Clinton and guests at the White House and Camp David. The Clinton Presidential records proposed for opening include photographs of President Clinton and Hillary Rodham Clinton greeting and meeting guests outside and inside the Family Theatre. Some of the film screenings were shown in the East Room, State Floor and Camp David for the requested

dates. The movie screenings were attended by staff, friends, and celebrities. Some of the guests photographed include Strobe Talbott, Gene Sperling, Lisa Caputo, Lew Wasserman, Ron Howard, Robin Williams, Matt Damon, Ben Affleck, Secretary of State Madeleine Albright, Barbara Streisand, John F. Kennedy, Jr., Lynda Carter, Gwyneth Paltrow, Robert Duvall, Harry Thomason and others. The events listed above were processed at the photograph contact sheet level. During the processing at the contact sheet level, additional photographs were processed and proposed to be opened, depicting events such as President Clinton attending meetings, receptions, and greeting staff and radio address guests; and photographs of interviews and a phone call from the Usher's Office.
