





MEMORANDUM FOR INFORMATION SECURITY OVERSIGHT OFFICE (ISOO)

SUBJECT: DARPA FY 17 Fundamental Classification Guidance Review Plan

Reference: ISOO Memorandum "FY 2017 Fundamental Classification Review", March 17, 2016

1. **PURPOSE:** This plan directs the conduct of the Fundamental Classification Guidance Review (FCGR) as required by the reference. The FCGR is an in-depth review of all DARPA Security Classification Guides to determine currency, accuracy and applicability under the requirements of Executive Order 13526, "Classified National Security Information," section 1.9 and 32 CFR 2001.16.
2. **COMPONENT MISSION SUMMARY AND ORGANIZATIONAL STRUCTURE:** DARPA's mission is to create and prevent technological surprise. DARPA is organized into six technical offices with individual technological thrust areas. DARPA's Security and Intelligence Directorate provides tailored security support across all directorates.
3. **SCOPE:** The FCGR includes all active Collateral security classification guides produced by DARPA. Cancelled security classification guides have not been reviewed. Guides reviewed and determined to be inactive or no longer necessary have been reviewed for declassification and/or cancellation. At present time, DARPA maintains 101 active Collateral security classification guides. In total DARPA has:
 - Reviewed 189 security classification guides during this FCGR.
 - Cancelled 29 security classification guides.
 - Maintain 59 inactive security classification guides.
- a. **Collateral Classification Guides.** DARPA has leveraged recent FCGR actions and consider all guides reviewed within the last five years as current provided a current DD Form 2024 is on file with DARPA Classification Management. Those security classification guides which have not been reviewed or those reaching the five year review date shall be reviewed. DARPA Classification Management have distributed security classification guides requiring review to the responsible Program Security Officer (PSO) along with the DD Form 2024 and guidance. The PSO, responsible Program Manager and Program Security Representative constitute DARPA's subject matter working group experts for each guide. The PSO have provided DARPA Classification Management a completed DD Form 2024 along with any recommendations for revision or cancellation.

- b. Schedule. DARPA will execute the FY 2017 FCGR in two phases with ISOO reporting periods incorporated as follows.
