Mr. Leonard Moss, Jr., became APL's Chief Security Officer, Insider Threat Program Senior Official (ITPSO), and Security Services Department (SECD) Head in April 2020. He was appointed to APL's Principal Professional Staff (PPS) in 2024. The Security Services Department provides comprehensive security support for the entire organization. SECD implements and oversees all aspects of security throughout APL,

to include DOD & other User Agencies, National Industrial Security Program (NISP), Intelligence Community (IC) efforts, Personnel, Physical, Procedural, administrative and technical security, as well as Insider Threat and Counterintelligence. Mr. Moss serves on the Laboratory's Executive Council, which is responsible for overall Laboratory strategy, vision and operations. He directs the development of an effective strategy to assess and mitigate risk, manage crises and incidents, maintain continuity of operations, and safeguard the organization. Security is a strategic advantage at APL. Mr. Moss is a highly accomplished executive with 30+ years of experience in leading small, medium and large organizations. Prior to joining APL he served as Senior Vice President for Corporate Security, Facilities and Real Estate and Chief Security Officer at DynCorp International (DI). He previously held leadership roles and developed exceptional security programs at numerous fortune 500 companies and the US Air Force.

Mr. Moss has been a pivotal and impactful leader of the national security industry. Effective October 2025 he was selected to serve a 4-year term as an industry member of the National Industrial Security Program Policy Advisory Committee (NISPPAC).
