**SLTPS-PAC Chairman Remarks**

- Michael Thomas (SLTPS-PAC Chair), opened the meeting.
- Discussed the Executive Order extending the Committee and the charter continuing. Also mentioned the lack of membership issue, wanting to fill the positions for the betterment of the program.

**Administrative Matters**

- Heather Harris Pagán, SLTPS-PAC Designated Federal Officer, briefed on administrative matters.
- Membership changes: Richard Dejausserand is serving as the Department of Homeland Security's (DHS) alternate vice chair. Tara Inverso left the Nuclear Regulatory Commission. We do not have a formal replacement for her. We do not yet have a vice chairman for SLTPS entities. There are nine SLTPS entity members vacant.

- Mary Deffenbaugh, a member of the public, asked about the disconnect with the Department of Energy. Richard Dejausserand, DHS, touched on about how there is no

clear and concise policy on submitting personnel. He advised there are no memorandum of agreements, and they are working on correcting that.
