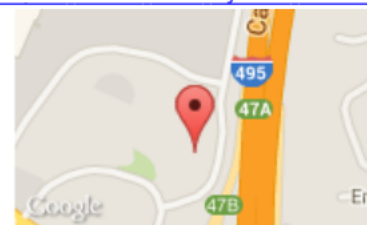

Redeem starting February 25, 2014; dinner hours are Tuesday-Saturday from 6-8:30 p.m. Some menu item exclusions may apply. Reservations are required and are subject to availability. Must call the Merchant and provide the Voucher number to make a reservation. Must present and redeem Voucher upon arrival to the Merchant's club. Please arrive 15 minutes early for all reservations. The Merchant has a business casual dress code; jeans, shorts, tennis shoes and sandals are not allowed. Voucher items and all other items purchased are subject to a mandatory 20% service charge (in lieu of gratuities) on the full value of the check before any credits, and applicable taxes, which must be paid by credit or debit card. The Merchant will not accept check or cash. Reservations are required and are subject to availability during Merchant's operating hours. Not valid on holidays and holiday weekends. Limit 4 Vouchers per table. Valid for dine-in only. Voucher cannot be combined with any other offer, discount or special promotion. Must be used in 1 visit. No stored value. Not valid for private parties. If you have not redeemed your Voucher on or before May 21, 2014 (the "Promotional Bonus Expiration Date"), you may redeem the Base Value of the Voucher toward the purchase of food and beverages until June 21, 2014. If you have not redeemed your Voucher on or before June 21, 2014, Travelzoo Local will automatically issue you, the person named on the Voucher, a refund credit in the amount of the Base Value within 7 days to the same credit card or form of payment used to purchase the Voucher.
