This responds to your November 25, 2014 request for assistance from the Office of Government Information Services (OGIS), which we received via U.S. mail. Your request for assistance pertains to your Freedom of Information Act (FOIA) request to the FBI for records about

Congress created OGIS to complement existing FOIA practice and procedure; we strive to work in conjunction with the existing request and appeal process. The goal is for OGIS to allow, whenever practical, the requester to exhaust his or her remedies within the agency, including the appeal process. OGIS has no investigatory or enforcement power, nor can we compel an agency to release documents. OGIS serves as the Federal FOIA Ombudsman and our jurisdiction is limited to assisting with the FOIA process.

The FBI denied your request for records related to example, citing FOIA Exemption 7(A). You appealed this decision, and the Department of Justice Office of Information Policy (OIP) upheld the FBI's determination.

Exemption 7(A) 5 U.S.C. § 552(b)(7)(A), protects law enforcement records pertaining to a pending or prospective law enforcement investigation or proceeding when release of information could "reasonably be expected to interfere" with that investigation or enforcement proceeding, meaning it would cause some articulable harm. As you are aware, Exemption 7(A) is temporal in nature and not intended to "endlessly protect material simply because it is in an investigatory file," according to the Department of Justice Guide to the Freedom of Information Act. In your correspondence to OGIS, you assert that all enforcement proceedings related to have been closed, and Exemption 7(A) no longer applies to these records.

We contacted the FBI to learn more about the agency's response to your request. According to FBI FOIA Public Liaison Dennis Argall, this

investigation remains open and FOIA Exemption 7(A) still applies to records responsive to your request. It may be helpful to know that as part of the appeals process on cases such as yours, OIP confirms that Exemption 7(A) is still applicable to the records sought at the time of the appeal.

In cases such as this where an agency is firm in its position, there is little for OGIS to do beyond providing more information about the agency's actions. I hope that this information about your request is useful to you. Thank you for contacting OGIS; we will now consider this matter closed.
