You requested assistance with your Freedom of Information Act (FOIA) request, No. NW to the National Archives and Records and Administration's (NARA's) National Declassification Center (NDC), and subsequent appeal, No. NGC to NARA's Deputy Archivist. We are sorry for our delay in responding to your request for assistance. Until recently, we were short staffed and not responding to requests as quickly as we would like.

Congress created OGIS to complement existing FOIA practice and procedure; we strive to work in conjunction with the existing request and appeal process. The goal is for OGIS to allow, whenever practical, the requester to exhaust his or her remedies within the agency, including the appeal process. OGIS has no investigatory or enforcement power, nor can we compel an agency to release documents. OGIS serves as the Federal FOIA Ombudsman and our jurisdiction is limited to assisting with the FOIA process.

We carefully reviewed your submission of information and understand that NARA's decision on behalf of the Department of Defense (DoD) to withhold portions of a NARA-held State Department document concerns you. In response to your appeal, NARA upheld its initial decision to withhold portions of the document you seek under FOIA Exemptions 1 and 3, 5 U.S.C. § 552(b)(1) and (3). You asked that OGIS "review the response and see if it is possible to change the outcome in any respect."

OGIS Facilitator Christa Lemelin contacted James Hogan, Chief of the Defense Freedom of Information Policy Office, and NARA FOIA Officer Joseph Scanlon to learn more about NARA's action on your request. Mr. Hogan discussed the document you seek with Office of the Secretary of Defense (OSD) FOIA Chief Paul Jacobsmeyer who agreed to reconsider the agency's initial determination. OSD will review the document and communicate the agency's decision to NARA and NARA will contact you with a supplemental response.

We hope you find this information about your request useful. At this time, OGIS can offer you no further assistance. Thank you for bringing this matter to OGIS. We will close your case.
