This responds to your October 29, 2015, letter to the Office of Government Information Services (OGIS), which we received via email. Your request for assistance concerns your Freedom of Information Act (FOIA) request to the National Security Agency (NSA).

As you know, Congress created OGIS to complement existing FOIA practice and procedure and we strive to work in conjunction with the existing request and appeal process. OGIS's goal, whenever practical, is to allow the requester to exhaust his or her remedies within the agency, including the appeal process. OGIS has no investigatory or enforcement power, nor can we compel an agency to process a particular request before others. OGIS serves as the Federal FOIA Ombudsman and our jurisdiction is limited to assisting with the FOIA process.

OGIS contacted NSA's Chief FOIA Officer, Sharon Linkous, to discuss your request. According to Ms. Linkous, the two year estimate that NSA provided to you is based on the NSA's experience with similar requests.

You also asked OGIS to assist you in obtaining an interim release of any records the agency has reviewed so far. According to Ms. Linkous, because the agency is waiting for the has not yet provided responsive records. Ms. Linkous further explained that your request was placed in the agency's queue according to the date on which it was received. Because the NSA has not begun processing responsive records, it is not possible for NSA to make an interim response.

In your submission, you expressed concern that you were unable to get in touch with the NSA FOIA Public Liaison. We discussed this matter with Ms. Linkous, who apologized that the Public Liaison never reached out to you. She mentioned that the most up to date contact information for the FOIA Public Liaison is on NSA's FOIA website, https://www.nsa.gov/public\_info/foia/index.shtml.

I hope you find this information useful. At this time, OGIS can offer no further assistance. Thank you for bringing this matter to OGIS. We will close your case.
