Dear agents of the United States and Representatives on the FOIAAC, In response to a reply I received today from the fugitive OGIS Director Miriam Nisbet (Director Nisbet) with respect to my email message of August 11, 2014 regarding Director Nisbet's testimonies before the U.S. Senate, let it be known the internet website search engine of the un-codified OGIS internet website yielded NO MATCHES when I entered "Miriam Nisbet", "Senate" "testimonies" (see <https://ogis.archives.gov/search.htm>). In other words, in order find such testimonies a member of the public is faced with having to blindly navigate and click the OGIS website pages until and unless he/she receives an actual notice from Director Nisbet informing how he/she is required to navigate and click the fugitive OGIS website in order to open the internet website page that reveals such testimonies. With respect to the internet website of the NARA, only the September 30, 2009 U.S. Senate testimony of OGIS Director Nisbet is published (see <http://search.archives.gov/query.html?qt=%22Miriam+Nisbet%22+%22Senate%22+%22testimonies%22&submit=GO&col=1arch&col=social&qc=1arch&qc=social>).
