(3) *During the administration of the President from January 20, 2009 until present*, the identities and titles of each officer(s) within the **GC** accountable for opening, reading and responding to **Email** from the public, for determining their status as legal Federal records and for deleting, purging or disposing them if determined to not be Federal records.

#### **Explanation of Request:**

*During the administration of the President from January 20, 2009 until present* I have been engaged in, and I am currently, and will continue to be, engaged in sending Email to certain offices and officers of the GC but need to know that the **GC** has established appropriate servers of public Email and has designated appropriate office(s) and officer(s) to be accountable for opening, reading and responding to public **Email**, for determining



their status as Federal records and for deleting, purging or disposing them if determined to not be Federal records.
