Dear agents of the United States, In accordance with Section 3(a)(1) of the APA and with 1 CFR 2.1(j) and 2.23 and published in 11 FR 177A-602-605 on September 11, 1946 was the National Labor Relations Board's document of general applicability and legal effect titled "Description of Organization" that was codified as 29 CFR 201.1-201.17 and published in the 1946 Supplement to the Code of Federal Regulations. In accordance with 1 CFR 1.45(a), an amendment to 29 CFR 201.3 was published in 12 FR 1925 on March 22, 1947 and in the 1947 Supplement to the Code of Federal Regulations. Although never repealed since such publication dates and absent any authority to discontinue the publication of 29 CFR 201.1-201.17 (such authority was not even allowed until codified as 1 CFR 17.2 on August 18, 1964), the NLRB's "Description of Organization" suspiciously disappeared. In its place, the regulations with respect to "labor-management relations in the Federal Service" were codified as 29 CFR 201.1-201.25 in the 1971 edition of the CFR (Source: 35 FR 2556-2557 of February 4, 1970 and 5688 of April 8, 1970).
