I was given a FOIA-ADVISORY COMMITTEE email address as a member of the NSA-GWU TODAY to express my frustrations with the FOIA PROCESS in what I consider years long stonewall and delay and denial of sources and now at the CIA a complete denial of justice as I have filed a OIG-CIA complaint in a denial to me and Don Pageler a survivor of that attack on the USS Liberty 8 June, 1967 in matters the 8 June 1967 IDF attack on the USS Liberty in International waters. Don and I have been told by the CIA-FOIA as read in our OIG- CIA -FOIA complaint sent days ago by registered UPS letter to the OIG-CIA that a question would be answered in the matters of a CIA Document 3 times by CIA FOIA Staff and NO answer has been forthcoming to Don and Me. So we filed a days ago OIG-CIA-FOIA complaint as the law will allow us to do so FOIA-ADVISORY COMMITTEE. There were undeniable laws of my Jewish Messiah and the Ten Commandments and the Talmud and Federal laws that were broken that tragic day 8 June, 1967. I as a Jewish veteran of Cold War I war veteran must when I beyond a reasonable doubt believe the attack was a deliberate attack on the USA research these matters at FOIA and NARA and the CIA and FBI and Army and Navy Intelligence and NSA and OSD and other Intelligence Agencies as I and Don Pageler have for years with some results showing the attack as deliberate . I have an ACTIVE NARA NIXON AND NARA DC ID CARD . I have been given a NARA-COLLEGE PARK FLIP-FLOP BY ROBERT REED first in that NO DOCUMENTS IN KISSINGER'S NSSM-40 RELATED TO THE USS LIBERY ATTACK; AND THEN WHEN I QUESTIONED THIS DECISION MR. REED SAID WELL MAYBE NONE. He was at another Agency after years as a Staff Member of NARA, College Park so my request by the DOJ to ask him what he meant goes by law unanswered to this day . After Don and I DECLASSIFIED FOR THE FIRST TIME PARTS OF KISSINGER'S NSSM-40 AND THE NSA-GWU DECLASSIFIED THE REST OF KISSINGER'S NSSM-40 NO FEWER THAT 169 PAGES RELATED TO THE ATTACK ON THE USS LIBERTY 8 JUNE 1967. And a recent Documentary on the attack showing audio tapes of the IDF attack given to the world thank God by Israel show the attack in my understanding was deliberate. I and Don Pageler want the CIA-FOIA to answer our CIA-FOIA questions as promised by the CIA no less than 3 times by the CIA-FOIA Staff to us now without delay, please FOIA ADVISORY COMMITTEE. Don and I just wonder since this unanswered by months delay to our CIA-FOIA questions does not VIOLATE OUR FOIA RICHTS UNDER FEDERAL LAW AND CONSTITUTION. The attack 8 June 1967 was tragic at the least and a war crime at the most sinister. I am a Jew and my whole kin have been Jews since the beginning thousands of years ago when all 3 faiths were created by Abraham Issac and Jacob. I cannot because of my faith NOT research these matters so help me my Jewish Messiah ; as I live with this Jewish guilt in these matters so described above to my end days on earth as it will be in Jewish Heaven.
