##### **Extent**

11 email messages

##### **Access**

Collection is open to all researchers. Access to Biden Vice Presidential records is governed by the Presidential Records Act, as amended (PRA) (44 USC 22) and the Freedom of Information Act (FOIA) (5 USC 552, as amended) and therefore may be restricted in whole or in part in accordance with legal restrictions and exemptions.

This segment of records responsive to the FOIA request is withheld in full, pursuant to the access provisions of the Freedom of Information Act as outlined in the Presidential Records Act.

**Scope and Content**

The materials in this series are a selective, not necessarily all inclusive, body of records responsive to the topic of FOIA case 2022-0113-F. Certain email messages were determined to be responsive in accordance with parameters outlined by the requester.

This series consists of email messages sent to and from Vice President Biden's "robinware456@gmail.com," "JRBWare@gmail.com" and "Robert.L.Peters@pci.gov" email addresses. This includes messages containing the term "Turkey" that were sent between April 1, 2015 and April 16, 2015. Materials include briefing books, memos and forwarded press articles.

**System of Arrangement**

Records responsive to this FOIA request were found in the Biden Vice Presidential Electronic Records collection which includes email messages and electronic files. These records are maintained in the Executive Office of the President instance of the Electronic Records Archive (EOP ERA) which contains electronic records created or received by the administration of President Barack Obama. These electronic records are born-digital files and are primarily .eml, .pdf, .wpd, and .doc files.

The responsive electronic records retrieved from EOP ERA are saved in search results lists (SRLs) and are arranged chronologically by creation date.

The following is a list of the SRLs saved and processed in response to FOIA 2022-0113-F[28]:
