### **Scope and Content**

The materials in this series are a selective, not necessarily all-inclusive, body of documents responsive to the topic of FOIA request 2023-0055-F.

This series consists of transmittal memoranda along with tab dividers and copies of Memoranda of Conversations (MEMCONS) and Memoranda of Telephone Conversations (TELCONS) which were routed to Vice President Cheney's National Security Affairs office. This series contains two TELCONS with Prime Minister Anders Fogh Rasmussen of Denmark for March 2003. The additional memoranda within this series primarily document President George W. Bush's and/or Vice President Cheney's discussions with other foreign leaders. Additionally, there is a small segment of memoranda related to discussions which occurred in March 2002 and April to June 2003.

Due to national security restrictions, approximately three-fourths of this material remains closed. The closed content are the MEMCONS and TELCONS.

### **System of Arrangement**

Records responsive to this FOIA request were found in Cheney Vice Presidential Records: White House Staff Member and Office Files.

Staff Member and Office Files are the textual records created and/or maintained by White House staff members within their individual offices. These files document all levels of administration activity.

Staff Member and Office Files are processed at the folder level, and the documents within are maintained in their original order. Since the files are processed at the folder level, individual documents contained within these folders may not be wholly responsive to the subject area of this FOIA request.
