

#### Senior Agency Official for Records Management 2022 Annual Report

The National Archives and Records Administration (NARA) requires Senior Agency Officials for Records Management (SAORM) to provide an annual report demonstrating how agencies are handling important records management initiatives as identified by NARA.

NARA uses the reports to determine the overall progress of the federal government in managing its records and the transition away from paper to digital formats, and to identify best practices and model solutions within federal agencies.

On June 28, 2019, the Office of Management and Budget (OMB) and NARA issued a memorandum, *Transition to Electronic Records* (M-19-21), to ensure that all federal records are created, retained, and managed in electronic formats. M-19-21 gave agencies until the end of December 2022 to comply with several specific deadlines.

On December 23, 2022, OMB and NARA issued a new memorandum, *Update to Transition to Electronic Records* (M-23-07) reinforcing the goals in M-19-21 and extending the 2022 deadlines to June 30, 2024.

Additionally, on January 1, 2021, Congress enacted the Preservation of Electronic Messages and Other Records Act, amending 44 U.S.C. Chapter 29, that requires the electronic capture, management, and preservation of such electronic records in accordance with the records disposition requirements of 44 U.S.C. Chapter 33.

This year's SAORM report provides an opportunity for agencies to report on plans and progress towards electronic recordkeeping and preservation under these requirements, as well as other important records management initiatives.

### The reporting period begins on January 9, 2023, and reports are due back to NARA no later than March 10, 2023.

NARA plans to post your 2022 SAORM report on the NARA website upon receipt. Please ensure that your agency's report is a publicly releasable version. This action is in the interest of transparency in government and to promote collaboration and communication among agencies. NARA intends to list any non-responding agencies in a summary report on our website. Instructions for Reporting:

- This template covers records management program developments, including those related to the transition to electronic recordkeeping as required by M-19-21 and M-23-07.

The Federal Communications Commission hired a contractor to digitize all paper mail received during the pandemic which has positioned the agency to comply with NARA's requirement to be fully electronic ahead of the June 30, 2024 requirement.

The FCC continues to work diligently to meet the goal of managing and preserving all permanent records in electronic format with appropriate metadata by June 30, 2024. During CY 22, we made progress on identifying electronic information systems across the agency and drafting records schedules. With the help of a newly acquired file analysis tool, we have worked with Information Technology (IT) to index FCC repositories to help clean up our shared network drives. In addition, we transferred approximately 300 boxes of permanent paper records to the Washington National Records Center (WNRC) and will continue this effort throughout CY23.

### 4. Has your agency taken action to meet the goal to manage and preserve all <u>temporary</u> records in an electronic format by June 30, 2024? (M-19-21, 1.3 and M-23-07, 1.3)

The FCC has taken action to meet the goal to manage and preserve all temporary records in an electronic format by June 30, 2024. We have determined that approximately 99% of our inventory of more than 400 information collections are received, managed and preserved in an electronic format.

The FCC has an informal information governance framework that connects the CIO, SAORM, ARO, RM Staff and FOIA Public Liaison. In fact, each of these roles are held by employees in the Office of the Managing Director and the SAORM, ARO, RM Staff, and FOIA Public Liaison all work for the Associate Managing Director responsible for records management and the FOIA service center. In addition, the security team and privacy officer often contribute to meetings and matters involving records, information technology systems and FOIA. Organizationally, this framework allows for more efficient and effective coordination among these roles.

### 7. Has your agency developed policies and procedures to ensure the capture and preservation of electronic messages, including when hardware or software is upgraded?

Per <u>FCC Instruction 1115.2</u>: Electronic Mail Records Retention, dated APR 2019, Capstone was implemented for managing email. The FCC, in coordination with our IT staff, is currently exploring solutions of expanding Capstone to include text messages, chats, and voicemails.
