

Senior Agency Official for Records Management 2022 Annual Report

The National Archives and Records Administration (NARA) requires Senior Agency Officials for Records Management (SAORM) to provide an annual report demonstrating how agencies are handling important records management initiatives as identified by NARA.

NARA uses the reports to determine the overall progress of the federal government in managing its records and the transition away from paper to digital formats, and to identify best practices and model solutions within federal agencies.

On June 28, 2019, the Office of Management and Budget (OMB) and NARA issued a memorandum, *Transition to Electronic Records* (M-19-21), to ensure that all federal records are created, retained, and managed in electronic formats. M-19-21 gave agencies until the end of December 2022 to comply with several specific deadlines.

On December 23, 2022, OMB and NARA issued a new memorandum, *Update to Transition to Electronic Records* (M-23-07) reinforcing the goals in M-19-21 and extending the 2022 deadlines to June 30, 2024.

Additionally, on January 1, 2021, Congress enacted the Preservation of Electronic Messages and Other Records Act, amending 44 U.S.C. Chapter 29, that requires the electronic capture, management, and preservation of such electronic records in accordance with the records disposition requirements of 44 U.S.C. Chapter 33.

This year's SAORM report provides an opportunity for agencies to report on plans and progress towards electronic recordkeeping and preservation under these requirements, as well as other important records management initiatives.

The reporting period begins on January 9, 2023, and reports are due back to NARA no later than March 10, 2023.

NARA plans to post your 2022 SAORM report on the NARA website upon receipt. Please ensure that your agency's report is a publicly releasable version. This action is in the interest of transparency in government and to promote collaboration and communication among agencies. NARA intends to list any non-responding agencies in a summary report on our website. Instructions for Reporting:

- This template covers records management program developments, including those related to the transition to electronic recordkeeping as required by M-19-21 and M-23-07.
- Please be brief and precise in your answers. Limit answers to each question to no more than 500 words.

The Board includes records management as part of the foundation of its information governance framework.

The Board's Records Management Program (RMP) uses its governance and oversight responsibilities to enhance the role of records management in information governance. The SAORM and the RMP participate in the development of information management policy by actively serving on the Board's Data Council, Executive Oversight Group (EOG) for Information Technology, the Software Review Board, the Business Technology Strategic Committee (BTSC), and other committees and workgroups.

The RMP issues policies, requirements, and procedures for information governance including, but not limited to, incorporating record keeping functionality in the design and development of new systems and applications; migrating systems; and decommissioning systems, applications, and collaboration sites.

The RMP also ensures the incorporation of recordkeeping functionality in electronic systems by participating in the design and development of new systems through the Board's System Development Methodology (SDM) process, Cloud governance, and by reviewing requests to establish new collaboration sites.

The RMP reviews and certifies that legacy systems meet the requirements of a recordkeeping system as stated in 36 CFR 1236. The RMP also evaluates records in systems, applications, and collaboration sites scheduled for decommissioning or migration to ensure records are managed and preserved as required.

7. Has your agency developed policies and procedures to ensure the capture and preservation of electronic messages, including when hardware or software is upgraded?

Note: Electronic messages means electronic mail and other electronic messaging systems that are used for purposes of communicating between individuals. Electronic messages that satisfy the definition of a federal record under the Federal Records Act are electronic records.
