Background Information The policy of Designating, Cruising, Scaling and Accountability states that in preparing and administering timber sales, sale officials must use a practical and efficient method of timber designation; Ensure that timber cruising specifications fit the method of sale, whether the payment basis depends on the cruise estimate or scaling after felling; Ensure that only designated trees are cut; Provide for effective accounting of logs and trees sold; and Ensure that protected trees and resources are undamaged.
