Background Information

The goal of the USDA Forest Service invasive species program is to reduce, minimize, or eliminate the potential for introduction, establishment, spread, and impact of invasive species across all landscapes and ownerships. Using inventory data collected from a variety of sources, the Forest Service develops estimates of the size of targeted infestations and the rate of spread for those species or groups of species to determine the extent and progression of invasive species that have been introduced into aquatic and terrestrial ecosystems. Sometimes considered the "second line of defense" after prevention, early detection and rapid response (EDRR) is a critical component of any effective invasive species management program. When new invasive species infestations are detected, a prompt and coordinated containment and eradication response can reduce environmental and economic impacts. This action results in lower cost and less resource damage than implementing a long-term control program after the species is established.
