1.	<p>This agency requests disposal authority for 414 cu. ft. of unscheduled records presently stored in the Washington National Records Center. These records consist of land records such as plat maps, abstracts and deeds for individual sellers and purchasers of tracts of land on the rural rehabilitation projects administered by the Resettlement Administration and Farm Security Administration, predecessors of the Farmers Home Administration.</p> <p>These records are covered by Accession Nos. 096-62A0775 (412 cu. ft.) and 096-74-0003 (2 cu. ft.).</p> <p>This past accumulation of records which are no longer generated cover a period from 1934 to 1942. They have not met the administrative or legal needs of this agency as requests for the material in these accessions average about one per month.</p> <p>We request authority for these records to be retained until October 1, 2002 ¹⁹⁹⁰, and then destroyed.</p>
